EXPLOSIVE ORDINANCE DISPOSAL BOMB SUIT ENSEMBLES
ADDENDUM 2
April 21, 2023**

This Addendum answers questions submitted by the deadline, including a revised pricing matrix.

The due date for submission of bids is extended to **April 28, 2023**.

Q. Can you please provide further details on the other capabilities the bomb suit must be able to meet so that we can submit a correct bid with what the COG agencies need? There is also no size requirement, color, or accessories listed in the solicitation. Bomb suits come in size small through extra-large, where extra-large has a different price point. Can you provide a list of those accessories as there are multiple options?

The following additional specifications are included as part of Section III, SPECIFICATIONS AND STATEMENT OF WORK:

- C. Suits must come in a range of sizes. If pricing differs for sizes, or if individual parts of the ensemble are available in different sizes for pricing purposes, please provide that pricing as part of the bid. Final size determinations will be performed after award, in cooperation with Participating Agencies.
- D. The suit ensemble shall include the following accessories:
 - a. Integrated lighting which can remotely change lighting from white, to red, to blue in a hands-free environment (included).
 - b. Ratcheting full foot protection (included).
 - c. A breathing apparatus face shield (optional, priced separately).
 - d. The ensemble must operate and come with a BB2590 battery, to maintain compatibility with existing equipment.
- E. Color of the suit shall be determined by Participating Agencies. If there is a variation in price based upon the color, please provide that price difference on an attachment to the bid. Final color determinations shall be made after award, in cooperation with Participating Agencies.
