Addendum No. 6

City of Frederick Specifications Revisions

This Addendum No. 6 revises delivery instructions and adds another delivery address for the City of Frederick in Section V of RFP #18-008, as follows:

1. The delivery instructions are revised as follows:

~~“Contractor shall verify delivery requirements according to each of the following locations”~~ Contractor shall adhere to the following delivery instructions:

THE ABOVE DELIVERY DATES AND QUANTITIES ARE ESTIMATES ONLY. STORAGE FACILITIES ARE LIMITED AT FREDERICK CITY, AND WE MUST INSIST ON THIS METHOD OF DELIVERY. DESIGNATED DELIVERY HOURS ARE TO BE BETWEEN 7:00 A.M. AND 12:00 NOON MONDAY THROUGH FRIDAY AND ARE TO BE STRICTLY ADHERED TO.

SPECIAL REQUIREMENTS/RESTRICTIONS:

A. MAXIMUM TRUCK HEIGHT AT LINGANORE PLANT IS 12’8”

B. DELIVERIES TO DINGLE PLANT AND FISHING CREEK REQUIRE A SHORT BED STRAIGHT TRUCK (NO TRACTOR TRAILERS) EQUIPPED WITH A LIFT GATE. TRUCKING COMPANY MUST MAKE CONTACT VIA PHONE NO MORE THAN ONE (1) HOUR PRIOR TO DELIVER. (ONLY ACH, CL2 AND ZINCORTHOPHOS ARE DELIVERED TO DINGLE PLANT)

C. ALL EMPTY DRUMS AND SHIPPING PALLETS MUST BE PICKED UP BY THE SUPPLIER AT NO COST TO THE BUYER. ALL EMPTY DRUMS AND SHIPPING PALLETS MUST BE PICKED UP ONCE AN ORDER HAS BEEN RECEIVED. THIS IS TO INCLUDE DISPOSABLE AS WELL AS REUSABLE TYPES. NO EXCEPTIONS

D. DRUM OR PALLET DEPOSIT FEES MUST BE INCLUSIVE IN BID PRICING NO ADDITIONAL FEES WILL BE ALLOWED.



E. OSHA/MOSHA/EPA:

a) MATERIAL SAFETY DATA SHEETS MUST BE PROVIDED WITH YOUR BID SUBMITTAL AS WELL AS WITH INITIAL SHIPMENT OF ALL CHEMICALS FROM SUPPLIER

b) SUPPLIER IS RESPONSIBLE FOR MEETING ALL CURRENT SAFE TRANSPORT REQUIREMENTS FOR EACH CHEMICAL DELIVERED TO THE CITY.

c) ANY SHIPMENT WHICH CANNOT BE UNLOADED IN A SAFE MANNER SHALL BE RETURNED TO THE SUPPLIER AT NO COST TO THE CITY. SUPPLIER WILL BE CONTACTED PRIOR TO ANY RETURN OF GOODS SO THAT THE PROBLEM CAN BE PROPERLY NOTED AND CORRECT.

d) SUPPLIER IS TO ADHERE TO ALL RISK MANAGEMENT PROGRAMS FOR DELIVERY REQUIREMENTS.”

2. The following delivery address is added:

All other terms and conditions of the RFP remain unchanged.
