Ms. Strasmore will brief the group on the results to date of DDOT's dockless shared vehicles project. The <u>project</u> which began in September 2017, will be extended until the end of 2020. Eight private dockless companies currently operate e-scooters in the District: Bird, Bolt, Jump, Lime, Lyft, Razor, Skip, and Spin. Only Jump operates e-bikes.

## 10:00 A.M. 4. DOCKLESS "MICRO-MOBILITY DEVICES" IN ARLINGTON

Jim Larsen, Bureau Chief, Arlington County Commuter Services

In October 2018 Arlington launched a 9-month *pilot project* to provide structure to the operation and use of Shared Mobility Devices (SMDs) within the County and to evaluate their impacts. SMDs are considered to be pedal bikes, electric-assist bikes (e-bikes), and electric-assist scooters (e-scooters) that do not require a station, as is required by the County's station-based <u>Capital Bikeshare</u> service.

On Nov. 16, 2019, the County Board <u>adopted regulations</u> for e-scooters and other shared micro-mobility devices that will allow their use on sidewalks (with limitations), trails, and bike lanes, unless specifically signed or marked otherwise. The County's adopted ordinance goes into effect on Dec. 31, 2019.

Mr. Larsen will present the results of the <u>evaluation report</u> on the original 9month pilot program, and discuss the newly adopted regulations.

#### 10:30 A.M. 5. DOCKLESS SCOOTER SHARE IN THE CITY OF ALEXANDRIA

In January 2019 the City of Alexandria launched a pilot program to allow private companies to operate shared mobility devices (such as dockless bicycles and scooters available for rent) in the City through September, and the pilot was administratively extended through the end of 2019. Ms. Caudullo will present on the results of that program.
