Foreclosure – Regional Summit

- COG hosted the region's first summit on foreclosure, with approximately 200 attendees
- Served as the first snapshot of the extent of the foreclosure problem in the Washington region
- Addressed acquisition of foreclosed properties, best practices in housing counseling, and ways to engage the foundation community in pro-active foreclosure prevention and mitigation solutions
- COG provided \$175,000 worth of grant support to six nonprofits providing direct foreclosure prevention and mitigation services

Foreclosure - Neighborhood Stabilization Program

- HUD program designed to support communities negatively impacted by foreclosure
- Second round of funding (first competitive round)
 providing up to \$1.93B
- Eligible activities:
 - Homebuyer assistance for the purchase or redevelopment of foreclosed properties
 - Acquisition, rehab and rental/sell of foreclosed properties
 - Demolition of blighted, foreclosed properties
 - Creation of land banks



- □ Requested \$33.9M
 - Homebuyer assistance for 369 units
 - Creation of a regional acquisition fund
 - Acquire, rehab and sell 135 units
 - Acquire, rehab and rent 46 units
- Consortium partners
 - Enterprise Community Partners
 - National Community Stabilization Trust
 - The Urban Institute

Target Communities

- Each jurisdiction recommended "at risk" and "tipping point" communities/census tracts...
 - 24 tracts for both Fairfax and Prince George's counties
 - 22 tracts within Prince William County
 - 5 tracts within the City of Bowie
 - 2 tracts within the City of Alexandria
 - 1 tract in Gaithersburg
- ...for a total of 78 census tracts

Foreclosure - Non Profit Capacity Building

- "Housing in the Nation's Capital" Advisory Board Member
 - Seventh annual report about housing in the Washington metropolitan region focused on the foreclosure crisis and its effects on the local housing market and residents
- Conducting a scan of foreclosure prevention agencies across the region
 - Seek to develop a comprehensive report and set of recommendations to increase region's capacity and create a regional network for housing counseling services

Affordability & Long Term Planning

- Implement our NSP activities
- GWU Capstone Project
- Pursue federal Transit Oriented Development grant opportunity
- Update Affordable Housing Tool Kit
- Create a regional affordable rental housing database
- Greater Washington 2050
 - Affordable housing targets (new and existing stock)

Homelessness – Annual Enumeration Study

- Preparing for our 10th regional enumeration of the homeless population
- One day point-in-time snap shot of persons served by nine local jurisdictions
- Counts the number of people found on the streets, in emergency shelters, in transitional and permanent supportive housing, or otherwise homeless and in need of a safe shelter

Homelessness – Potential IRE Project Topic

- Can we predict whether homelessness will increase throughout the region as a direct result of foreclosure?
- Would need to identify and research indicators
 suggesting potential vulnerability to homelessness
- Example indicators include increased requests for rental or utility assistance, foreclosure notices, or increased provision of free and reduced school lunches
- Results would determine whether to continue collecting the data/following trend to alert and assist local governments
