# TPB CITIZENS ADVISORY COMMITTEE MONTHLY REPORT

December 13, 2018

The CAC met on Thursday, December 13 for briefings on the Environmental Justice Analysis of Visualize 2045 and highway safety targets. There was also a discussion about autonomous vehicles and transportation technology.

#### **VISUALIZE 2045: ENVIRONMENTAL JUSTICE ANALYIS**

Sergio Ritacco, TPB Transportation Planner, briefed the committee on the environmental justice analysis of the TPB's recently passed long-range transportation plan, Visualize 2045. He covered the methodology and explained how the TPB's Equity Emphasis Areas were used to determine that the plan does not have a disproportionately high or significantly adverse impact on those population groups.

The committee asked a series of clarifying questions to get a better understanding of the analysis. They asked about whether historic data was used, how specific modes were analyzed and commute sheds defined, and about how the determination was made. Some members of the committee recognized that not all questions could be answered by this study. Particularly, people were curious about the type of jobs that were accessible, the level of service for different areas, and how ridehailing companies might impact the data.

#### PERFORMANCE BASED PLANNING AND PROGRAMMING: HIGHWAY SAFETY TARGETS

Jon Schermann, TPB Transportation Planner, briefed the committee about federal requirements to set highway safety targets as part of the performance-based planning and programming rule. He described how the District, Maryland, and Virginia set their safety targets and how the TPB incorporates those targets into its own targets for the planning area. He provided some background to contextualize trends and provide some expectations as to how the targets may be used in the future.

The committee was curious to know how fatalities and serious injuries for motorized scooters and bicycles might be counted in the future, and asked about how infrastructure design might be informed by the safety data. They were curious to know if COG would use the data to identify safer road elements for the region. The committee looks forward to the opportunity for the TPB to compare its data from other similar MPOs across the country.

### AUTONOMOUS VEHICLES/TRANSPORTATION TECHNOLOGY AND THE TPB

Andrew Meese, TPB Transportation Planner, briefed the committee on current trends related to autonomous vehicles and other emerging technology issues. He also described how some other MPOs are planning to work with these new technologies.

The committee discussed the data infrastructure that is required to support more computer-based travel. They also wondered about data privacy and making sure that users are aware of what data is being collected and how it might be used. The committee is frustrated by the mis-match in current policy and legislation for dealing with existing technology. They hope that the federal government can lead with legislation. The committee expressed some concerns about the possible impacts that

autonomous vehicles may have on the labor force. One member of the committee advocated that the transportation technologies be required to be accessible to the disabled, including people who use wheel chairs and are blind.
