Last year's federal surface transportation reauthorization act (SAFETEA-LU) established new requirements for the coordination of human service transportation programs, including jobs access programs, and programs for seniors and persons with disabilities. At the TPB meeting on July 19, the TPB is scheduled to establish a task force to develop a coordinated plan for human service transportation. The board is also scheduled to approve steps for the TPB to become the designated recipient for Job Access/Reverse Commute and New Freedom program funds. Michael Eichler of the COG/TPB staff will brief the CAC on these new roles and responsibilities.
