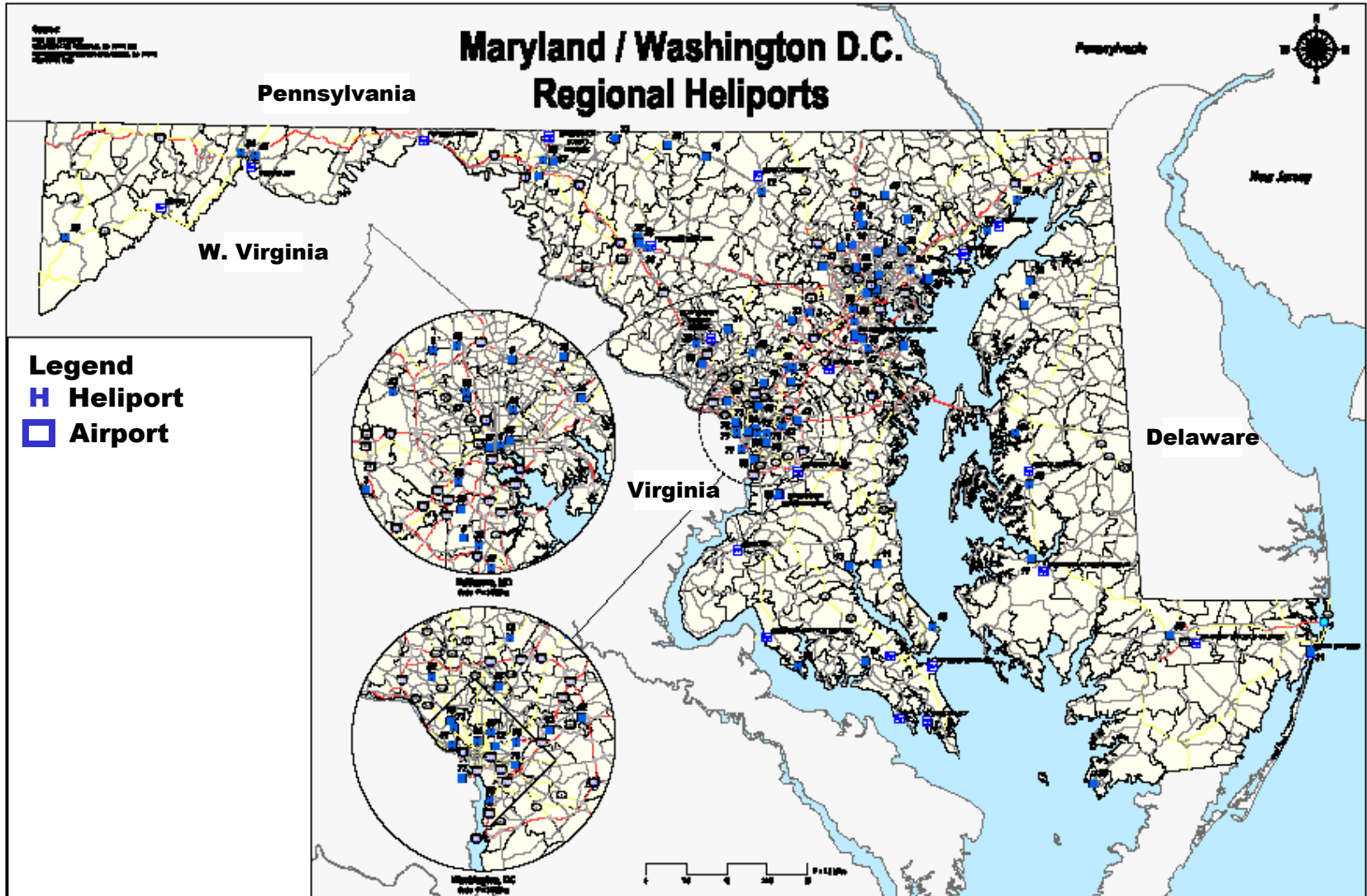

Existing Heliports and Airports



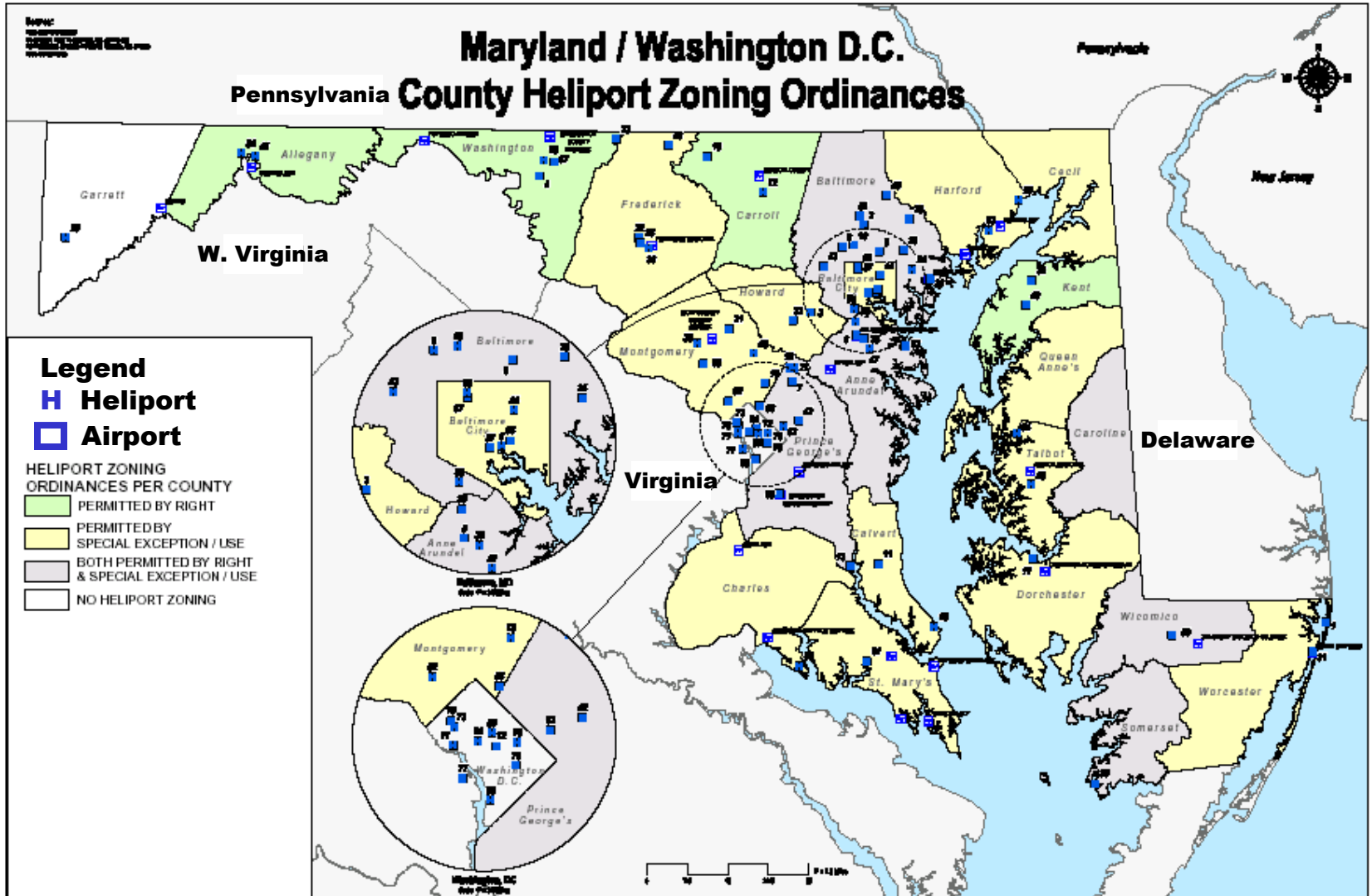

Known Noise Sensitive Areas



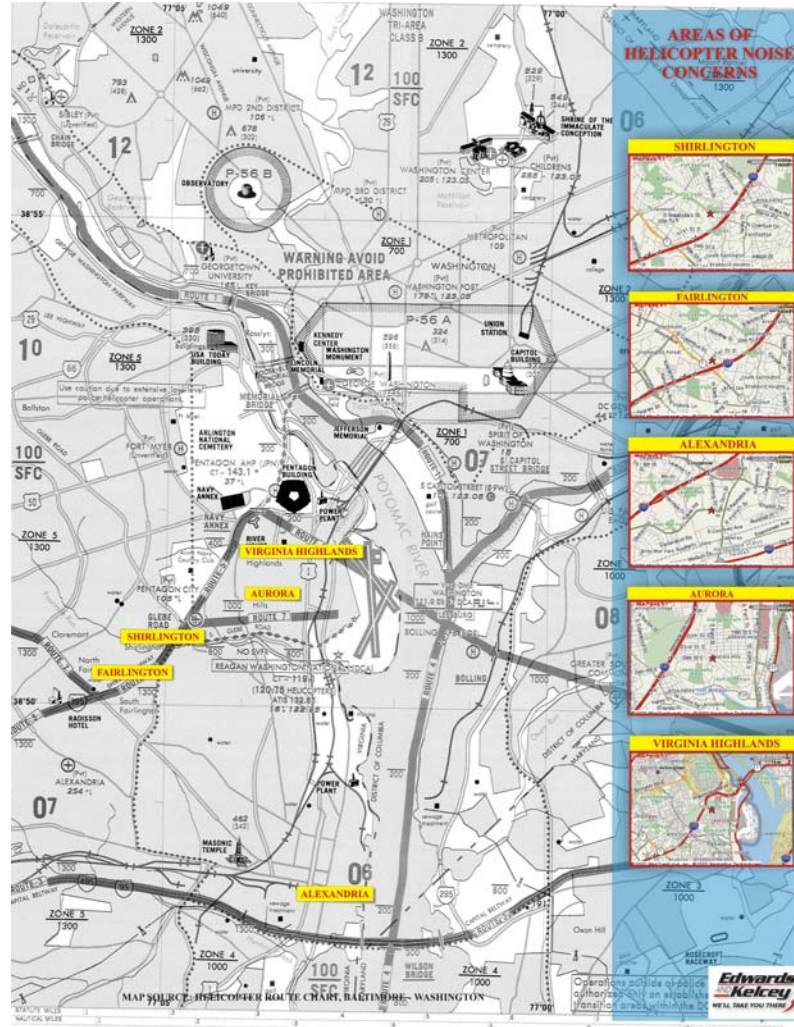
