### 12:40 P.M. 4. OZONE SEASON UPDATE AND DESIGNATIONS FOR THE 2015 STANDARD

#### 1:05 P.M. 5. FINE PARTICLE MAINTENANCE PLAN

Metropolitan Washington agreed to submit a revision to the 1997 fine particle maintenance plan after mobile vehicle emission budgets were recalculated using MOVES2014 modeling tool. In August, the U.S. EPA announced that the 1997 standard for fine particles will be revoked as of October 24, 2016. Staff will brief members on the impacts related to the fine particle maintenance plan.
