

## THINK BIG - Core Framework for Reducing Emissions

- THINK BIG was developed internally in 2022 to inform programs, projects, policies and other implementation strategies under Arlington County's Community Energy Plan.
- This approach now influences the AIRE Program for County emissionsreductions actions across all sectors.

# THINK BIG - Core Framework for Reducing Emissions

Arlington aggressively implements an "all-of-government" emissions-reduction strategy.

- With commercial operation of the Maplewood Solar Farm in Dec 2022, Arlington County will achieve 100% renewable energy for government electricity use, 3 years ahead of the Board's 2025 target date.
- Q4 2022 will also see completion and use of the Facilities Decarbonization Tool, developed by AIRE with Cadmus, to model, inform and measure government facilities upgrades and new construction (first in Virginia).
- Continuum of TOD/Smart Growth development with National Landing, Amazon HQ2, and Plan Langston Boulevard.
- AIRE pivoted its prior Implementation Framework to an operationalized Community Energy Plan Roadmap, adopted in June 2022. The Roadmap covers all six CEP sectors, and is structured along execution phases of 1-2 years, 3-5 years, 5-10 years, and long-term (beyond 10 years) implementation targets. It serves as a "climate calendar" for defining, timing and measuring success.














## Selected Measures and Strategies - Transportation

- 15% of County non-emergency passenger fleet is EV highest share in the NOVA region.
- EV School Bus Pilot (partnership among APS, Facilities, Equipment Bureau and AIRE).
- EV Rate Ordinance adopted by the Board in June 2022.
- ARTBus Zero-Emissions Study moving into Board briefings later this year and completion Q1 2023.
   ARTBus is the only NOVA region 100% CNG municipal bus fleet.
- DecTrans Plan (Decarbonization of Transportation)
  Government and Community.
- Total Cost of Ownership Comparative Study completion Oct-30-2022.
- EVSE Capital Program for Government Fleet and Public-Access EVSE on Government Sites.




# Annual VMT Declining Even With Ongoing Community Growth




### More Arlington Households are Going Car-less

#### 2020 Household Travel Survey




# Arlington Residents Drive Alone Less and Use Non-SOV Modes More than the Region

#### 2010 Household Travel Survey




#### 2020 Household Travel Survey




