Chlorides/Salt Impacts

COG is working with COG's members and various parties to coordinate on this water quality issue as research and strategies are being developed across the region to address winter storm sodium chloride applications. As this is a multi-media issue, this coordination includes water quality, drinking water, stormwater and potentially wastewater implications.

Salt Management Planning

COG staff are tracking developments for including salt management planning in local MS4 permits. In Maryland, MDE staff are hosting a meeting on May 4th that will address plans to include a requirement for salt management plans in MS4 Phase I permits. The meeting will feature a presentation on the State Highway Administration's salt management plan and explore ways in which local governments can partner with existing SHA salt management initiatives.

In Virginia, the Department of Environmental Quality (DEQ) has formed a Stakeholder Advisory Committee (SAC) to assist with the development of a Salt Management Strategy for northern Virginia. In addition to regional jurisdictions and utilities, COG is a member of the SAC. DEQ will be holding a SAC technical session on May $24^{\rm th}$ at the Fairfax Water Griffith Treatment Plant, and will hold a SAC meeting in June.

At the July 13th WRTC and July 20th CBPC meetings, COG staff will provide updates on these Maryland and Virginia efforts.

PAH Sealants Planning by DOEE

The District Department of Energy and the Environment (DOEE) presented, at the March WRTC and CBPC meetings, the issue of polycyclic aromatic hydrocarbons (PAH) concentrations in other types of pavement sealants, beyond just coal tar. PAH is a human carcinogen, harmful to aquatic life. Several Maryland jurisdictions and the District of Columbia have a coal tar sealant ban. DOEE is considering amending their ban to broaden it and base it on PAH concentration, and to also have a product certification.

At the March 16th CBPC meeting there was discussion of sending a CBPC letter to the National Sanitation Foundation International in support of developing a product certification. DOEE is gathering information about certification terms and costs, and is also looking at

ways of broadening the support base. For the moment the concept of a CBPC letter is on hold, as the CBPC may be more instrumental in developing partnerships and regional support. Staff are evaluating such options and will be making recommendations to the CBPC.

Biosolids Class A Workshop at Blue Plains

COG staff is coordinating an informal workshop Wednesday morning, May 30th, from 10 a.m. to noon where DC Water staff will discuss what they've learned in establishing a marketing program for Bloom, their *Class A* biosolids. The workshop will be held on site at the Blue Plains Water Recovery Facility.

A Request for Information (RFI) was sent to vendors on March 23, 2018. Twenty-six vendors responded and provided information on the chemicals needed by the partners, as well as allowing COG to prequalify firms. One of the goals of this solicitation is to create supply chain security for the regional procurement of these chemicals and protect our water supply & wastewater from critical service interruption. In addition, the solicitation will include the COG Rider Clause, which will permit other jurisdictions to "piggy-back" on any resulting contract.

The final bid documents should be ready within in the next two weeks and COG plans to have contracts in place before the new fiscal year (June 30, 2018).

<u>Alexandria and Arlington Receive Virginia Governor's Environmental</u> Excellence Awards

On April 5th, the City of Alexandria and Arlington County were recognized by Virginia DEQ as Environmental Excellence Award silver medalists for their joint Four Mile Run Tidal Wetland and Living Shoreline Restoration Project, completed in 2017, which removed five miles of hardened stream banks, restored two acres of wetland habitat, and is quantifiably reduce nitrogen, phosphorous and sediment pollution.

Regional Drought and Water Supply Outlook - April 2018

- The current U.S. Drought monitor indicates that the COG region is experiencing some abnormal dryness and a small area of moderate drought.
- The latest U.S. Seasonal Outlook indicates that drought removal is likely in our region.
- Precipitation, streamflow and groundwater levels are below normal - local reservoirs are full.
- In Maryland-MDE, all regions are under a normal status.
- In <u>Virginia-VADEQ</u>, a drought watch advisory has been issue for the Northern Virginia drought evaluation region. It applies to public or private groundwater supplies or private surface water supplies in Fauquier, Prince William and Loudoun counties. Water systems using the Potomac River or Occoquan Reservoir are not included.
