Introduction

- Provides the status of the air quality for the whole country every year.
- Provides weighted scores and grades for each county.
- Reports top 25 most polluted cities for ozone and PM2.5 (24-hour & annual).





Methodology

ALA Methodology

Used number of code orange and above days and factors assigned by ALA to those days instead of the Design Value to calculate Scores/Grades/Ranks for Ozone & 24-Hour PM2.5 for cities.

Used Design Value to assign grades/ranks for Annual PM2.5 for cities.

EPA Methodology

EPA uses Design Value for evaluating attainment status for ozone and PM2.5 standards for an area.





Air Quality Rankings

ALA published list of top 25 most polluted <u>cities</u> in the 2021 report

- City here refers to the Combined Metropolitan Statistical Area (CMSA).
- Rankings were provided for the Combined Washington-Baltimore-Arlington region. (Baltimore is not part of the Washington, DC ozone nonattainment area. It was also never part of the Washington, DC PM2.5 nonattainment area.)
