RE: **Oppose Pompeo Amendment to HR 2354**

Dear Representative Bartlett:

On behalf of the Climate, Energy and Environment Policy Committee of the Metropolitan Washington Council of Governments (COG), I am writing to urge you to oppose the Pompeo Amendment to HR 2354, which prohibits funds from this appropriations act to be used to carry out the Vehicle Technologies Program of the Department of Energy (DOE). This amendment would eliminate funding for the program that manages the Clean Cities Initiative, which aids local and regional efforts to purchase clean vehicles and develop alternative fuel infrastructure.

Clean Cities programs promote and assist in measurable reduction in petroleum-based fuels and increase use of alternative fuels, vehicles, and infrastructure; this assists in improving air quality, energy security, and economic opportunities. COG has firsthand knowledge of the benefits of the Clean Cities programs because it hosted the region's Clean Cities Coalition from 1993 to 2010.

Not funding the Vehicle Technologies Program would eliminate \$200 million in competitive grants to up to 30 communities for the deployment of electric vehicle infrastructure through the Clean Cities Community Readiness and Planning for Plug-in Electric Vehicles and Charging Infrastructure funding opportunity.

We urge you to oppose this Pompeo Amendment to HR 2354. The prohibition of funding for the Vehicle Technologies Program of the Department of Energy through this act would be a step backward in assisting local and regional efforts to increase adoption of domestic clean fuel and vehicle technologies.
