Item 3. Fine Particle Standard Remanded to EPA

Description:

On February 24, the U.S. Court of Appeals for the District of Columbia remanded the 2006 annual fine particle standard (National Ambient air Quality Standard) back to EPA. The court found that EPA did not adequately explain why the 2006 annual standard of 15 ug/m3 is sufficiently protective of public health with an adequate margin of safety. Mr. Ruck will discuss the court's action and Ms. Rohlfs will discuss the implications for regional air quality planning.

Item: 4 EPA: Proposed GHG Reporting Rule

Presenter: Jeff King, Senior Environmental Planner

Description:

On March 10 EPA proposed a draft greenhouse gas reporting rule. The rule, which will be proposed in the Federal Register soon, sets mandatory reporting requirements for emitting sources, defined as fossil fuel producers and vehicle and engine manufacturers. Sources emitting 25,000 metric tonnes CO2 equivalent or more would be required to report for calendar year 2010. Staff will discuss the proposed regulation and its relation to voluntary reporting systems like the Climate Registry.

The proposed MWAQC FY 2010 Work Program and Budget will support air quality planning to meet the future ozone standard and, possibly, a future lower annual fine particle standard, in addition to providing technical support for climate and energy initiatives in the region. The proposed budget for the core MWAQC programs remains unchanged from 2009. The Budget Committee reviewed the proposed budget in December and this month. The MWAQC Technical Advisory Committee reviewed the proposed work program and budget in March and recommended its adoption to MWAQC.

Item: 6 Status of Local Air Quality Commitments:

Results of Survey

Description:

The region's air quality plans (SIPs) contain several local government programs to reduce ozone and fine particle pollution. The local government plans are non-regulatory, or "voluntary," but need to be tracked annually to determine if the SIP commitments are being met. Staff surveys local governments annually regarding their progress in implementing local voluntary commitments, including energy efficiency, green power purchases, and tree canopy programs. Overall, the region is on track in meeting its commitments in the voluntary bundle. One outstanding item is for states to retire NOx allowances commensurate with the emission reduction credits for renewable energy and energy efficiency measures.

The proposed Fairfax County budget includes elimination of funding for Fairfax County operated air quality monitors. The measure would save \$230,000 in the County's Department of Health budget. The five monitors are used to track concentrations of ozone and fine particles. Staff will discuss how the monitors are used in the air quality plan (SIP) and for air quality forecasting. A public hearing on the proposal will be held on March 30, 31, and April 1.
