The U.S. Environmental Protection Agency's (EPA) Clean Power Plan (CPP) standards were finalized in 2015 to reduce carbon emissions from power plants. In October 2017, the EPA proposed to repeal the CPP and will be accepting comments on this action until January 16, 2018. COG staff will present information on the proposed repeal and will present a proposed approach to a comment letter from CEEPC and MWAQC for submission to the regulatory docket.

Recommended Action: Provide direction to staff on development of a letter to US EPA.
