### 12:30 P.M. 7. APPROVAL OF DRAFT ROUND 9.0 COOPERATIVE FORECASTS

David Levy, Planning Directors Technical Advisory Committee Chairman

COG established the Cooperative Forecasting program in 1975 to enable local, regional, and federal agencies to coordinate planning using common assumptions about future growth and development. The board will be briefed about the draft 9th major series of Forecasts, "Round 9.0," which was approved

by the Planning Directors Technical Advisory Committee (PDTAC) at their February 19 meeting and reflects new national and regional economic trends and projections. The board will be asked to approve the draft Round 9.0 Forecasts for use by the National Capital Region Transportation Planning Board (TPB) in the Air Quality Conformity Analysis of the 2016 Financially Constrained Long Range Transportation Plan (CLRP) and the FY 2017-2022 Transportation Improvement Program (TIP). Consistent with board policy, final approval of the forecasts will occur this fall, concurrent with TPB approval of the Air Quality Conformity results.

#### COMMITTEE WORK FEATURE OUTREACH CALENDAR MEDIA

#### NATIONAL CAPITAL REGION TRANSPORTATION PLANNING BOARD (TPB)

At its February meeting, the TPB was briefed on nine of the projects being proposed for the 2016 update to the CLRP that are either new or have significant changes, and it released the project submissions for a 30-day public comment period.

#### METROPOLITAN WASHINGTON AIR QUALITY COMMITTEE (MWAQC)

MWAQC agreed to submit a revision to the 1997 fine particle maintenance plan after mobile vehicle emission budgets were recalculated. At its February meeting, the committee agreed to open the revised fine particle maintenance plan for a 30-day public comment period.

#### **REGION FORWARD COALITION**

The coalition was briefed on two reports at its February meeting: The State of the Region: Economic Competitiveness Report 2016 and The Kogod Greater Washington Index: Millennials. The coalition discussed providing affordable housing and attracting and retaining the millennial workforce.

#### NATIONAL CAPITAL REGION EMERGENCY PREPAREDNESS COUNCIL (EPC)

The EPC discussed the region's response to the January 20 snow/ice event at its February meeting, including what was done well, what could have been done better, and how to more effectively utilize regional situational awareness and strengthen communication.

#### HUMAN SERVICES PUBLIC SAFETY POLICY COMMITTEE (HSPSPC)

HSPSPC approved its 2016 priorities, which will include a focus on affordable housing, veteran housing, workforce training, gang violence, police officer body cameras, obesity, and drug abuse.



#### Heart of COG: LYNN WINCHELL-MENDY

Earlier this year, the TPB approved nearly \$8 million in funding for projects to address the transportation needs of older adults and persons with disabilities across the region, made possible by the FTA's Enhanced Mobility Program. COG Transportation Planner Lynn Winchell-Mendy plays a central role in guiding grantees through this multipart process and related programs.

#### NARC HOLDS CONFERENCE IN DC

National Association of Regional Councils (NARC) held its 2016 National Conference of Regions in Washington, DC, on February 7-9. COG Executive Director Chuck Bean attended the conference, which included presentations on economic development, transportation planning, and homelessness.

#### COG REACHES OUT TO NEW BOARD MEMBERS

Chuck Bean met with new COG Board members in February and will continue to meet with members in March to discuss the role of board members and provide an orientation about COG.

#### COG BOARD MEMBERS JOIN REGIONAL DELEGATION IN CUBA

Montgomery County's Roger Berliner, Ike Leggett, and Nancy Navarro, and District of Columbia's Muriel Bowser joined more than 40 local officials on an exploratory trip to Cuba.

#### CDC BRIEFS COG MEMBERS ON STATUS OF ZIKA VIRUS

In follow-up to the Zika virus presentation at the February COG Board meeting, COG hosted an informational briefing with the Centers for Disease Control (CDC) on March 1 for members of the COG Board, Chief Administrative Officers Committee, HSPSPC, and Health Officials Committee. CDC Deputy Division Director Dr. Jennifer McQuiston briefed the group on the status of the Zika virus and domestic Zika responses, suggesting that jurisdictions continue to educate their communities and work with local health officials.

#### COG ENVIRONMENT DEPARTMENT STAFF MEMBER TRAVELS TO PHILIPPINES

COG Urban Watershed Programs and Homeland Security Chief Steve Bieber traveled to Manila, Philippines to participate in an ICMA fellowship. While in Manila, Bieber shared information about best practices and lessons learned related to urban watershed management as well as regional environmental, climate, energy, and sustainability goals.

#### CBPC COMMENTS ON VIRGINIA WATER PROTECTION REGULATIONS

On January 28, the Chesapeake Bay and Water Resources Policy Committee (CBPC) submitted a letter to the Virginia Department of Environmental Quality (DEQ) regarding their proposed revisions to the Virginia Water Protection Permit Regulations. The CBPC recommended that DEQ delay any nonemergency regulatory changes until after a comprehensive economic analysis is completed.

#### COMMUTER CONNECTIONS MEETS WITH DC EMPLOYERS

Commuter Connections participated in a DC Department of Employee Services event to promote DC's new transit benefit ordinance to employers.



#### Outreach Highlight: IFC AND COG LAUNCH ONLINE EMERGENCY SERVICES DIRECTORY

COG and the Interfaith Conference of Metropolitan Washington launched an online directory to serve over 300,000 people in need of emergency services across the region. #### RESOLUTION APPROVING THE DRAFT ROUND 9.0 COOPERATIVE FORECASTS FOR USE IN THE AIR QUALITY CONFORMITY ANALYSIS OF THE 2016 CLRP AMENDMENT AND 2017-2022 TIP

WHEREAS, on September 10, 1975, the Board of Directors of the Metropolitan Washington Council of Governments (COG) authorized the development of a Cooperative Forecasting Program as a component of the Metropolitan Growth Policy Program; and

WHEREAS, the purpose of this program is to provide current forecasts of population, households, and employment growth and change for use in metropolitan planning programs, including the Water Resources, Transportation Planning, Air Quality, Energy Resources, Metropolitan Development and Housing Programs; and

WHEREAS, the Planning Directors Technical Advisory Committee has been actively engaged during the past year in developing the ninth major new series or "Round" of forecasts based on current regional development trends and new national economic projections, as the basis for further study of land use/transportation relationships to comply with Federal regulations implementing the Clean Air Act Amendments and Fixing America's Surface Transportation Act, or "FAST Act"; and

WHEREAS, to further enhance coordination between regional land use and transportation planning, on February 12, 2003, COG adopted Resolution R8-03, recommending that approval of each round of the Cooperative Forecasts should occur concurrently with the completion of the National Capital Region Transportation Planning Board's (TPB) Air Quality Conformity Analysis of the Transportation Improvement Program (TIP) and the Financially-Constrained Long Range Plan (CLRP); and

WHEREAS, on February 19, 2016 the Planning Directors Technical Advisory Committee recommended approval of the ninth major series of Cooperative Forecasts – "Round 9.0" – for use by the staff of the TPB in the year Air Quality Conformity Analysis of the 2016 CLRP Amendment and the FY 2017-2022 TIP.

#### NOW, THEREFORE, BE IT RESOLVED BY THE COG BOARD OF DIRECTORS THAT:

The board approves the Round 9.0 Forecasts attached for use by the TPB and commends the Planning Directors and its Forecasting Subcommittee for their work to develop the projections.

The board charges the Region Forward Coalition and the Planning Directors Technical Advisory Committee with monitoring the Round 9.0 Cooperative Forecasts to identify any potential changes in assumptions about land use, transportation, and the region's economy and modify the Round 9.0 Cooperative Forecasts as necessary.

## **Stephen Fuller**

Dwight C. Schar Endowed Faculty Chair and University Professor Director, Center for Regional Analysis



Stephen Fuller joined the faculty at George Mason University in 1994 as Professor of Public Policy and Regional Development. He served as Director of the Ph.D. Program in Public Policy from July 1998 to June 2000 and from July 2001 to July 2002. He also serves as Director of the Center for Regional Analysis. In September 2001, the GMU Board of Visitors appointed him University Professor and in July 2002 he was named to the Dwight C. Schar Endowed Faculty Chair.

Prior to joining the Mason faculty, he served on the faculty at George Washington University for twenty-five years, including nine as Chairman of the Department of Urban Planning and Real Estate Development and one as Director of Doctoral Programs for the School of Business and Public Management.

Fuller has authored more than 500 articles, papers, and reports in the field of urban and regional economic development including monthly reports on the Washington metropolitan area and Fairfax County economies.

His research focuses on the changing structure of metropolitan area economies and measuring their current and near-term performance. In 1990 he developed a monthly series of indicators to track the current and near-term performance of the Washington area economy. He also developed leading and coincident indices for Fairfax County in 1997. These monthly reports are available on the Center for Regional Analysis website. His research includes studies on the impacts of federal spending, the hospitality industry, international business and the building industry on the Washington area economy. His international assignments include Kazakhstan, Georgia, Hungary and China as well as on-going projects in Portugal.

In August 2006, Governor Kaine appointed Professor Fuller to the Governor's Advisory Board of Economists. He had previously served on this Board under Governors Warner, Allen and Wilder. In 2003, he was a member of Governor Warner's Tax Reform Working Group. He also is a member of the CFO Advisory Group of the District of Columbia. Additionally, he serves on the Board of Directors of the Global Environment and Technology Foundation and Tompkins Builders Inc. He has been economic advisor to Fairfax County, VA since 1995 and has been appointed by the Board of

Supervisors to serve on the Board of Directors of the Fairfax County Convention and Visitors Authority. In 2007, he was appointed by Cardinal Bank as its Chief Economist.

In 1996, he was honored by the Economic Club of Washington as Educator of the Year and in 1997 was selected for the Richard T. Ely Distinguished Educator Award by Lambda Alpha International, an honorary society of land economists. He served as President of the Washington Chapter of Lambda Alpha from 1998 to 2000 and is a member of the Urban Land Institute's Washington District Council. In 2001, he was selected by NAIOP as a Distinguished Fellow, an appointment that extends through 2007.
