9:35 A.M. 2. ARLINGTON COUNTY'S NEW TOUR-BASED TRAVEL MODEL

Arlington Co. has embarked on the creation of a new travel demand model, to support the County's planning initiatives, including analysis of the new Amazon facility. The new model covers the entire TPB modeled region, but with greater focus and detail in Arlington Co. The model uses a simplified tour-based model, a streamlined type of discrete model that is easier to understand and runs faster than an activity-based model. The model features simplified drive-transit modeling, PnR lot choice and constraint, multipath transit processing, simplified mode choice with bus/rail split handled in a full transit assignment by period, walk/bike/taxi/TNC modes handled in mode choice, validated bike assignment, a telecommuting model, school and university trip purposes, and an autonomous vehicle model. The model is calibrated, a forecast is underway, and documentation and training will be completed by mid-September.
