<sup>&</sup>lt;sup>4</sup> Prince George's County program costs represented reflect two stormwater management fund sources; an ad valorem tax and the Clean Water Act utility fee. The ad valorem tax funds all aspects of traditional stormwater management (grey infrastructure, operations, maintenance, water quality etc., including costs for other departments aside from Environment. Funds from the Clean Water Fee are specific to water quality program expenditures. The annual program costs presented represent only DoE's expenditures, which include flood control/drainage improvements, NPDES MS4 permit compliance, USACE Partnership projects, and Bear Branch CIP projects.

Condo tier: Includes garden-style and hi-rise condos. Townhouse tier includes: townhouse-style condos, row townhouses, and semi-detached houses. Typical and large single-family tiers include: detached houses. All other 'non-residential' properties are 'variable' or calculated based on ERU. <sup>6</sup> This includes revenue and new dept issuance which is paid through the stormwater utility as debt service.
