### What is the RTDC?

- Collection of transportation related datasets
  - Includes our own datasets & data collected from member agencies
     & assembled by us
  - Additional Esri base maps for reference
- Latest release is web-based; accessed via desktop using the ArcGIS Viewer for Flex
- The application will be released at the TPB Travel
   Forecasting Subcommittee meeting on 30 November 2012
- Contains current functionality & data, with some exceptions
  - New: secure login screen; data download
  - Improvements to overall look and feel; design & query data ability

## Status report: transit related data

- MetroRail layer- (Metro lines & stations)
  - All stations now in the RTDC
  - Additional popup information associated with station layer
  - Remaining: Metro line popup; ability to query station data
- Transit Counts layer (average weekday ridership)
  - Added DC Circulator to be visible in the display of the routes
  - Improved popup design
  - Added in all available counts (see following slide for details)
- Widgets- query & advanced query reconfigured to allow easier searching of all transit routes and better display of results

  - 2011 network year transit available
  - Include 2009 (current) and 2011 years as separate layers
- Request to the Regional Bus Subcommittee (RBS) for additional data
  - Incorporate any outstanding count data in-hand not currently entered
  - New ridership/count data? We will especially need the new routes
  - New datasets?

- Cut off for data submittal 16 October (3 weeks from today \*)
- Final draft version 9 November \*
- RTDC unveiled to the TFS on 30 November
