




SWEEP Division

- Solid Waste Education and Enforcement Program
- FY14 budget = \$4.8 million
- FY14 FTEs = 47
- Sanitation Inspections and Enforcement
- Recycling Enforcement
- Inspectors can issue notices of violation (tickets)
- Fines range from \$75 to \$2,000
- Cases are heard by an Administrative Law Judge
- Monthly household hazardous waste, e-cycling, document shredding
- Helping Hand, community meetings, outreach to business community

D.C. Code § 8-1001

Litter Control Administration Act of 1985, 6-100, As Amended, D.C. Code § 8-801 et seq.

D.C. Code § 8-1001 requires all Commercial establishments, Residential properties, Government building and Schools within the District of Columbia to recycle. Purpose: eliminates criminal penalties for violations of sanitation and public space regulations and establishes an administrative adjudicative system for civil enforcement of these regulations.

Materials Required by Law

- The following items must be recycled.
- Paper (newspaper, office paper etc.)
- Plastic
- Aluminum Cans
- Steel
- Tin
- Glass (green, clear and brown)
- Corrugated Cardboard

Trash and Recycling Collections

- Collections are made from about 105,000 locations weekly
- Service population = residents living in one, two and three unit residential buildings
- About 64% of collections are made from alleys
- About 70% of customers receive once-a-week Trash Collection service. These customers received a new 96-gal Supercan in 2014.
- About 30% of customers receive twice-a-week Trash Collection service. These customers received a new 32-gal trash can in 2014.
- Everyone receives once-a-week Recycling Collection. In 2014 households received larger recycling cans.
- Once-a-week households received a new 64-gal recycling can. Twice-a-week households received a new 48-gal recycling can.

PURPOSE OF THE ENFORCEMENT PROGRAM

DPW is in charge of educating residents and commercial entities on all sanitation and recycling regulations and enforcing these regulations.. The inspectors and investigators of The Solid Waste Education and Enforcement Program (SWEEP) work with residents and businesses to keep the District clean. SWEEP also supports neighborhood clean-ups through the Helping Hand program and gives young people the opportunity to earn community service credits through the SWEEP Jr. program.

Our Experiences

- The District's solid waste problems are not unique, but they are compelling
- There is no landfill in the District of Columbia
- The District is changing new construction, new residents – which effects solid waste and solid waste collection

The issues most commonly mentions during our visits

- Storage space is at a premium in business
- Many businesses complain of tight budgets and reduced staffs
- Recycling requires changes in employee habits and rituals
- Language barrier with the cleaning staff
- Who's responsible, owner or tenant
- Proof of Service mail and postings

- Over flowing containers
- Illegal dumping
- Locating property owner's for commercial apartment with no property owner or management on sight.
- Contacting co-op and condo association
- Four unit buildings
