## The plan and TIP: What Can Be Revised Now? What Cannot?

Examples of what can change	What cannot change
<ul> <li>General text of the plan and TIP</li> <li>Project descriptions (for clarity, not to include new capacity impacts)</li> <li>Descriptive data</li> <li>PBPP targets and data (revisions will capture very recent data and target updates)</li> <li>URLs, photos</li> <li>Project costs- many updates expected for the final TIP</li> <li>Policy Priorities and Goals if the board took action to do so</li> </ul>	<ul> <li>Conformity inputs: projects, programs and policies included in the technical inputs for the Air Quality Conformity analysis (which is complete) cannot be added or deleted until the next plan update</li> <li>Information required to meet federal requirements cannot be removed</li> </ul>

Consistent with past plan cycles, comments on projects, programs and polices included in the constrained element would serve as input of agencies for the next/future updates of the plan.



### What changed since the draft?

- The types of changes included:
  - Revisions to language that described projects, to provide additional clarification.
  - Performance-based planning data updates based on newly available data,
  - Performance-based planning Transit Asset Management (TAM) updates based on recently-approved TAM targets
  - Updated URLs
  - New end Photo in Chapter 9
  - TIP data updates (as expected)

# Resolution to Approve the 2022 Update to Visualize 2045 and FY 23-26 TIP

- TPB staff recommend that the TPB take the following action:
  - Adopt Resolution R15-2022

     approving the 2022 Update to
     Visualize 2045 and the FY 2023-2026 Transportation
     Improvement Program (TIP)

The 2022 Update to Visualize 2045 long-range transportation plan and the TIP meet the federal requirements for fiscal constraint, and all other federal requirements.

# Resolution to Approve Air Quality Conformity Determination

- TPB staff recommend that the TPB take the following action:
  - Adopt Resolution R16-2022 finding that the 2022 Update to Visualize 2045 and the FY 2023-2026 TIP conform with the requirements of the Clean Air Act Amendments of 1990

The 2022 Update to Visualize 2045 meets the federal Air Quality Conformity requirements—mobile source VOC and NOx emissions associated with the plan/TIP are below EPA approved motor vehicle emissions budgets



### Resolution to Approve Self Certification

- TPB staff recommend that the TPB take the following action:
  - Adopt Resolution R17-2022 to self certify that the TPB is following the metropolitan transportation planning process

The TPB carries out a cooperative and comprehensive performance-based multimodal transportation planning process consistent with federal regulations (23 CFR § 450).

Representatives of the Departments of Transportation of the State of Maryland, Commonwealth of Virginia, and District of Columbia provide oversight, and sign the selfcertification document.



### What's Next?

- Staff are updating the Equity Emphasis Areas, using the TPB-Approved Methodology
- Staff will conduct the federally required Environmental Justice Analysis on the approved plan
- Staff are working internally regarding the next update and expect to share more about that process with the TPB and its committees in coming months
