# Regional Roadway Safety Program

- Established and funded by the TPB via Resolution R3-2021 in 2020 to support roadway safety efforts regionwide
- 28 projects have been awarded totaling \$1.78 million since 2020
- Projects include site-specific planning or preliminary design, education campaigns and toolkits, complete streets, local road safety plans, guidelines and standards, and more



# FY 2025 Solicitation

---

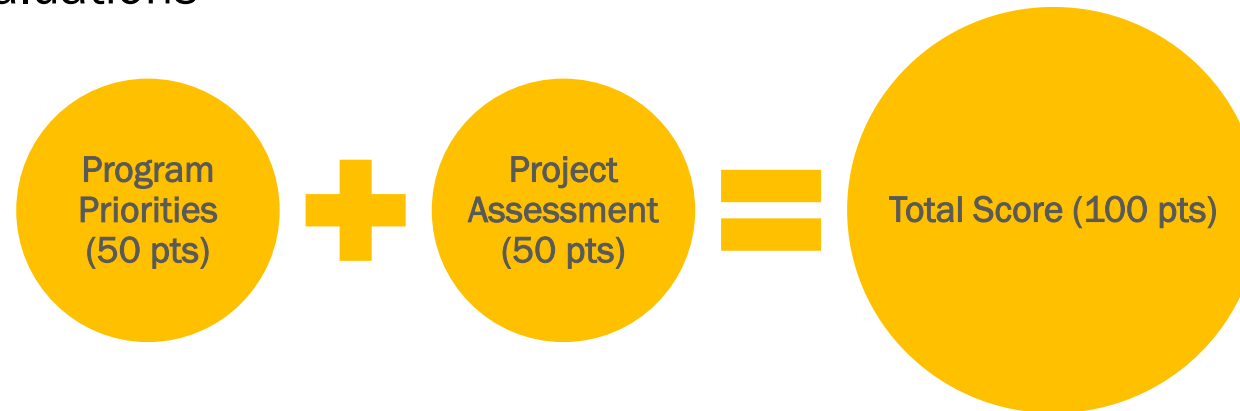
- TPB Staff solicited applications January 5 through March 8
- 18 applications were received totaling \$1,540,000 in funding requests
  - Nine applications from Maryland jurisdictions
  - Nine applications from Virginia jurisdictions
  - Ten applications sought to address safety concerns in arterials

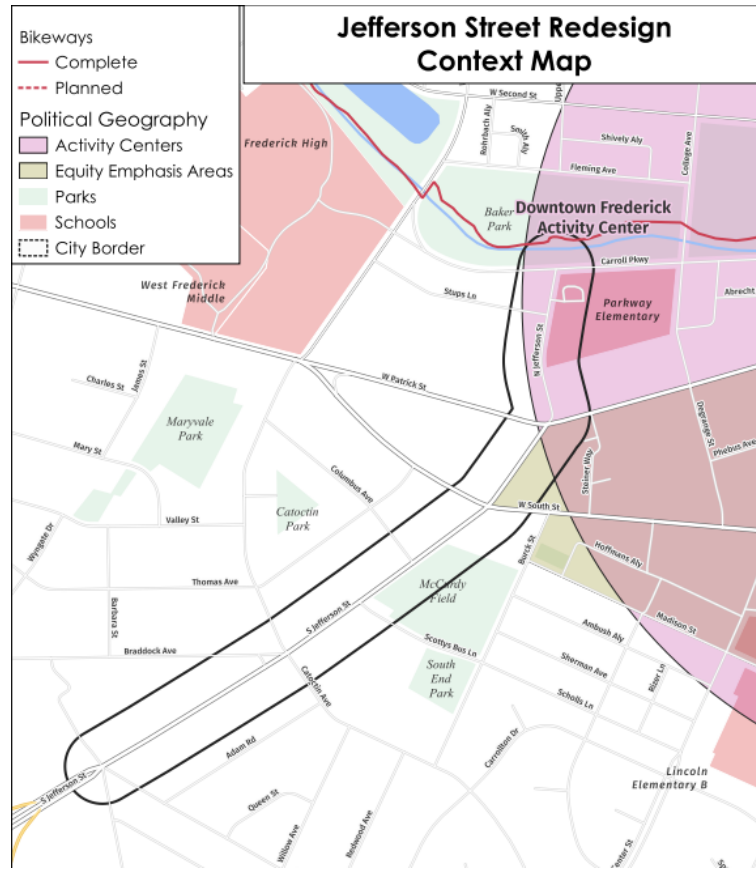

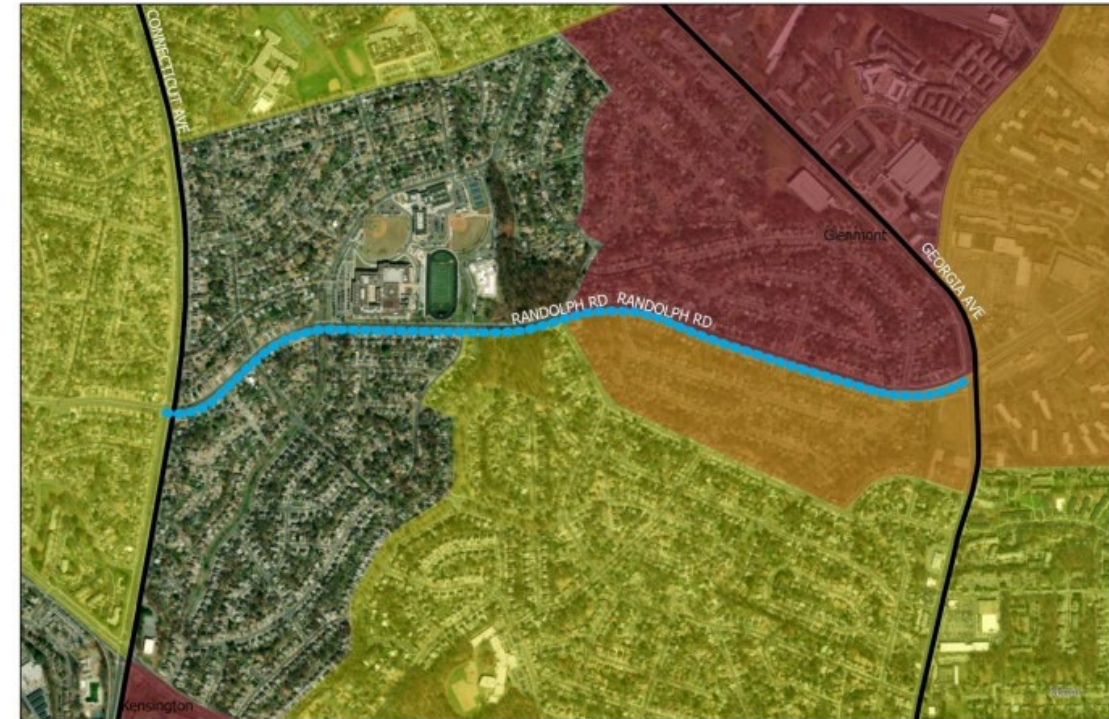

RANDOLPH ROAD SAFETY IMPROVEMENT PROJECT - LOCATION MAP



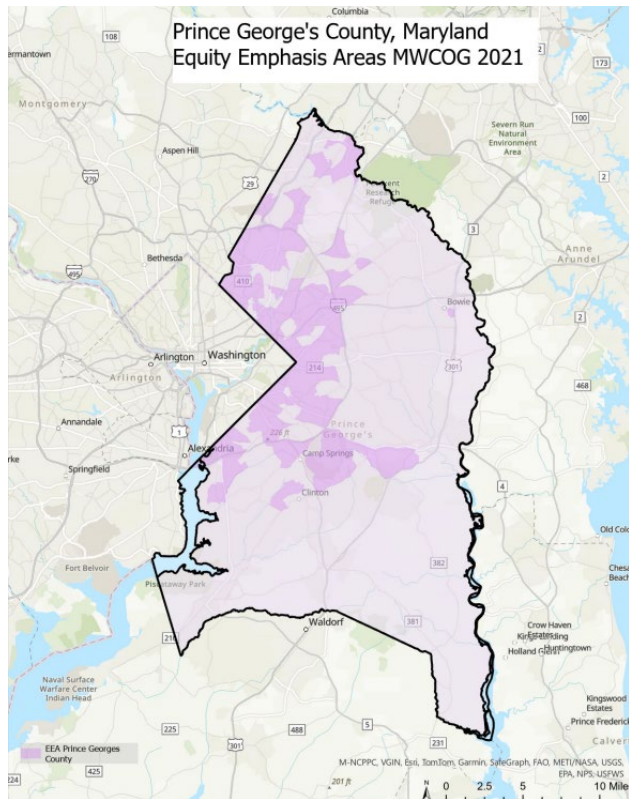

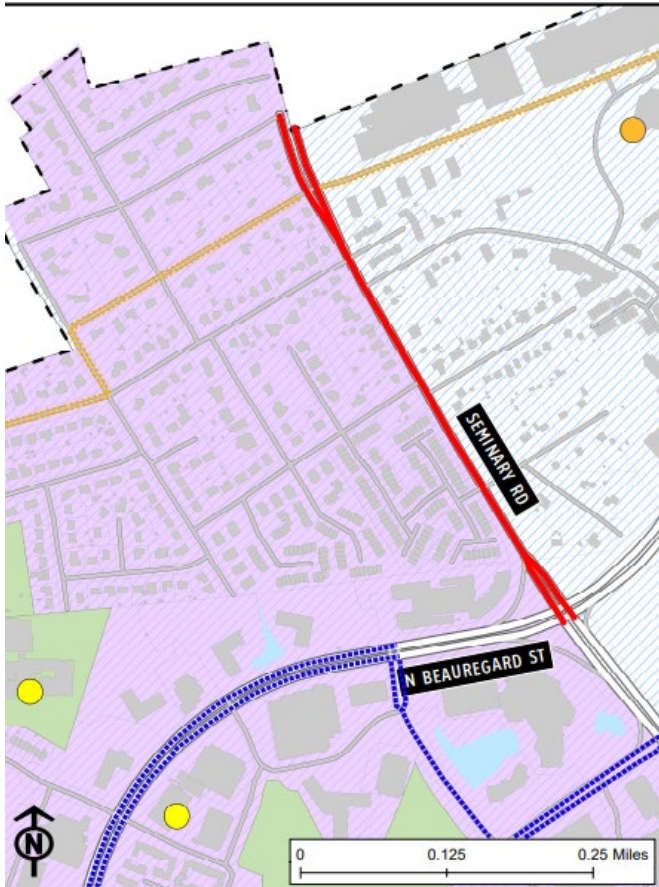
