I-66 Program Overview

Transform 66 Inside the Beltway Partnership 40-year agreement between NVTC and the Commonwealth

NVTC's Role

- Establish a selection process
- Plan and select multimodal improvements
- Issue grants to and coordinate with agencies to ensure efficient delivery
- Monitor effectiveness of projects
- Provide annual reports to the CTB
- Provide information to the public


Commonwealth's Role

- Widen I-66 eastbound between exits 67 and 71 (VDOT)
- Manage the design, construction, maintenance, and operations of I-66 Inside the Beltway toll facilities (VDOT)
- Approve NVTC's program of projects (CTB)









I-66 Commuter Choice Project Selection and Funding

- ✓ NVTC has funded \$22M in projects including parkand-ride lots, new bus services, bus stop improvements, bikeshare access to Metro, transit incentives, and traffic management tools.
- ✓ Initial program = \$10M
- ✓ FY 2019 program = \$12 M
- ✓ FY2020 program estimated to be approximately \$20 million





I-66 Commuter Choice FY2020 Eligible Project List

- 20 submitted projects
- \$32 million total funding request
- 8 applicants
 - Counties of Arlington, Fairfax, Loudoun, and Prince William
 - Cities of Fairfax and Falls Church
 - Town of Vienna
 - PRTC/OmniRide

I-395/95 Program Overview

NVTC (with PRTC)

- Establish an application, scoring, and selection process
- Issue grants to and coordinate with agencies to ensure efficient delivery
- Monitor effectiveness of projects
- Provide opportunity for public input
- Develop program of projects for submission to CTB
- Provide annual reports to the CTB
- Support communication efforts of grantees and overall program

Agreement between Commonwealth and TransUrban

- Convert remaining 395 HOV to HOT (extension of existing 95/395 HOT lane facility)
- Total length: 37 miles
- 70 year agreement
- Annual Transit Investment (ATI)
 of \$15M/year + 2.5% annual
 escalation
- Tolling scheduled to begin Fall
 2019


