Re: Coordination of Pedestrian and Bicycle Access to Transit Stations

Dear Chairman Kauffman:

On December 21, 2005, the National Capital Region Transportation Planning Board (TPB) received a report from its Citizens Advisory Committee (CAC) regarding the Committee's concerns about the need for better coordination of pedestrian and bicycle access to transit stations.

Recognizing that over 60% of riders access the Metrorail system on foot, good pedestrian access is critical to encouraging people to get to Metrorail stations by means other than driving. The TPB's Access for All Advisory Committee has pointed out that an accessible pedestrian environment at bus stops and rail stations is especially critical for people with disabilities. Recently, the TPB's Bicycle and Pedestrian Subcommittee indicated to the TPB Technical Committee as well as the CAC that there is no central point of contact at WMATA for coordinating pedestrian and bicycle issues and projects.

Given the importance of good pedestrian and bicycle infrastructure at Metrorail stations and bus stops, and that the provision of such infrastructure depends upon effective coordination between local governments and transit agencies, the TPB suggests that WMATA consider designating a point person for pedestrian and bicycle access to transit stations.

Thank you for your consideration of this matter. I look forward to working with you to further improve pedestrian and bicycle access in the National Capital Region.
