**1. REVIEW AND APPROVAL OF FOUR RESOLUTIONS TO AMEND THE  
FY 2021-2024 TRANSPORTATION IMPROVEMENT PROGRAM (TIP)**

TPB SR6-2021: an amendment to include funding for the H Street Bridge over Railroad and Cleveland Park Streetscape Improvements projects, as requested by the District Department of Transportation (DDOT).

TPB SR7-2020: an amendment to include funding for the MD 225 Mattawoman Drive Bridge Replacement project, as requested by the Maryland Department of Transportation.

TPB SR8-2020: an amendment to include funding for Bowie Road Culvert project, as requested by the Maryland Department of Transportation on behalf of Prince George's County.

TPB SR9-2020: an amendment to include funding four projects, as requested by the Virginia Department of Transportation.

**2. REVIEW AND APPROVAL OF A RESOLUTION TO TRANSFER FUNDS FOR THE  
DISTRICT OF COLUMBIA TAP PROJECTS**

Under the federal Transportation Alternatives Set-Aside Program (TAP), the TPB since 2012 has been responsible for selecting projects using sub-allocated funding for Suburban Maryland, Northern Virginia, and the District of Columbia. DDOT has identified unobligated funding from projects that were previously approved by the TPB in past years and has requested that some of those funds be transferred to projects, also previously approved by the TPB, that are ready to move toward construction. The Steering Committee will be asked to approve DDOT's requested transfer of funds.
