Between February 28 and April 1, TPB members completed a survey to gauge the TPB's interest in setting greenhouse gas (GHG) reduction goals and strategies specifically for the transportation sector. The findings from the survey were presented on April 20, at both a TPB work session and the TPB meeting. There appears to be consensus that the TPB could adopt both GHG reduction goals and strategies, and the TPB will discuss the optimum levels for the goals and the levels of implementation that could be pursued for the strategies.

10:10 A.M. 6. PBPP: CMAQ PROGRAM DRAFT TARGETS

The committee will be briefed on requirements under the federal performance-based planning and programming (PBPP) rulemaking for MPOs to set targets for CMAQ Program performance measures for traffic congestion and emissions reduction.
