


## FY 2018 – TPB Transit Planning Activities

- 2045 Visualize Long Range Plan
  - Funded component
  - Unfunded component (Long Range Plan Task Force)
    - Collecting TDPs and include transit improvements into Unfunded Projects list.
- Transit Asset and Transit Safety PBPP
- State of Public Transportation Report
- RPTS Meetings



### PBPP Rulemaking: Public Transportation Agency Safety Plans rule – Expected in February 2018



- The National Public Transportation Safety Plan final rule finalized the transit safety performance measures.
- The Public Transportation Agency Safety Plan, which will specify the transit safety target-setting process and timeline, is still pending. (Draft: 2/15/16)



# **PBPP - Transit Asset Management (TAM)**

- The Transportation Planning Board adopted initial TAM targets for the region at its June 21, 2017 meeting.
  - MPO targets need to be updated with the new long-range plan: Visualize 2045, which is due for approval in October 2018.
- By October 2018, providers of public transportation must report performance data and targets in the National Transit Database (NTD) within four months after their fiscal year end.
  - Providers must also develop formal TAM Plan (i.e., strategic planning document).
- TPB will need to incorporate any FY 2018 TAM data and FY 2019 TAM targets being reported into Visualize 2045.



# **DRPT - TAM Update**

- DRPT has set new FY2018 Transit Vehicle Useful Life Benchmark Targets. These targets apply to Tier 2 operators who have elected to participate in the state-sponsored Group TAM Plan.
- The aspirational targets for FY 2018 are:
  - Articulated 80% of vehicles within Useful Life Benchmark
  - 40 foot 80% of vehicles within Useful Life Benchmark
  - 35 foot 80% of vehicles within Useful Life Benchmark
  - 30 foot 70% of vehicles within Useful Life Benchmark
  - Under 30 foot 80% of vehicles within Useful Life Benchmark
  - Vans 50% of vehicles within Useful Life Benchmark
- The next step is to develop the Group TAM Plan, which is required to be submitted to FTA by September 30, 2018. DRPT will be holding a webinar in February 2018 with transit agencies that are participating in the DRPT group plan.



## LRPTF Initiative - Regionwide Bus Rapid Transit (BRT) and Transitways

Following the work of the Long Range Planning Task Force (LRPTF\_) through 2017, in December the Transportation Planning Board adopted five initiatives from the work of the task force, including

- Regionwide Bus Rapid Transit (BRT) and Transitways: BRT, transitway, and streetcar routes that are in jurisdictions' plans but not yet in the TPB's longrange plan would be added at various locations throughout the region. This initiative would also improve pedestrian access to transit stations and increase the amount of jobs and housing around the transit stations.

#### Initiative 4: Regionwide Bus Rapid Transit and Transitways

**Bus Rapid Transit/Transitway Networks** – Additional bus rapid transit (BRT)/transitway networks in Montgomery County, Prince George's County, Northern Virginia (TransAction 2040), DC, and a transitway from Branch Ave to Waldorf. *These lines are in addition to those already in the CLRP, which include: DC streetcar (Union Station-Georgetown), Corridor Cities Transitway, Crystal City Transitway Northern Extension, US-1 BRT (Huntington Metro to Woodbridge), West End Transitway (Van Dorn Metro to Pentagon Metro), and Tiger Grant Bus Priority Improvements.*

Existing local bus/streetcar fare pricing is assumed for the new BRT/ Transitways. Initiative also includes improved bicycle and pedestrian access.

**Land Use** – 2040 CLRP Round 9.0 Cooperative Land Use Forecasts were adjusted to have modest increase in employment and household densities in zones with new services, relocating employment and housing from outside activity centers within jurisdictions. Increase densities in TAZs with new BRT to 5 households/acre and 30 jobs/acre while maintaining the regional control totals

**Analysis Approach** – The new BRT/ Transitways with the stops are being coded in the MWCOG Model. The bicycle/pedestrian boarding mode shares to the BRT were altered in the MWCOG model to represent increased bike/ped accessibility to the BRT. A post distribution mode choice and assignment will be carried out using the person trip tables from the 2040 CLRP model.
