THE REGIONAL ECONOMIC MONITORING SYSTEM (REMS) REPORT – DECEMBER 2022

In November, over-the-year employment increased by 63,900 jobs or 1.9 percent in the Washington Metropolitan Statistical Area (MSA), while the national over-the-year employment increased by about 4.8 million jobs or 3.2 percent. Locally, the Leisure & Hospitality Sector gained 22,800 jobs and the Professional & Business Services Sector gained 10,400 jobs during the last year. (373,300 jobs were lost between March 2020 and April 2020) The region's inflation decreased in November to 5.6 percent from a rate of 6.5 percent in September. During November, the region's unemployment rate decreased to 3.1 percent, while the national rate remained at 3.4 percent. The 1,852 new housing units authorized during November 2022 represent a 7.4 percent decrease from November 2021, when 2,001 new units were started. 


Unemployment Rate Washington MSA and US


