In accordance with federal transportation law, TPB designated the region's Critical Urban Freight Corridors (CUFCs) in 2017 (Resolution R6-2018), plus amendments approved by the TPB Steering Committee in 2021 (Resolution SR4-2022). With changes enacted in the recent Infrastructure Investment and Jobs Act (IIJA), TPB has an opportunity to update and expand CUFC designations within Suburban Maryland. The committee will be briefed on the context and specifics of proposed changes to the CUFCs for Suburban Maryland, anticipated to be presented to the TPB Steering Committee for approval on May 3, 2024.
