Following up on May's discussion with members of the Transportation Planning Board (TPB) staff on highlights from "Visualize 2045" the region's long-range transportation plan and the joint July Planning Directors/Housing Directors Committee meeting, HDAC members will be briefed on recent discussions with COG Board members and a resolution directed at achieving an increased regional housing preservation and production goal by 2045.

Committee members will then discuss this request, whose aim is to determine how to create more housing to optimize transportation system performance and meet future job growth projections. Work will proceed in collaboration with COG's Planning Directors committee and continue through the end of the calendar year.

This work is expected to build on past discussions regarding existing best practices, to examine "what would it take?" individually and collectively to meet this challenge and charge from our region's elected officials.
