- Hilary Chapman will provide an update on the collaboration's status (programmatic and administrative) and will ask for input on recent questions from C4 staff.
 - Stakeholder kickoff meeting Thursday, June 17th at 12:30pm
- Discussion questions:
 - Need for Data Sharing Agreement between C4 and each CoC?
 - C4 will not be working with raw data, but some communities may require DSAs for interpretation/analysis of cleaned data. (C4 will be providing TA and coaching around which data to pull and how to run the analysis and interpretation.)
 - Need for DSA based on data type (quantitative vs qualitative)? Some communities do not require one for quantitative data but do for qualitative data.
 - Level of difficulty with HMIS vendor? (i.e., length of time or other administrative hold ups that you might encounter?).
 - Do CoCs have fairly easy access to any ad hoc reports they request? Which CoCs do not manage this with CoC staff?
 - Opportunities for streamlined interaction with C4 staff
 - Data Metrics workgroup (for questions similar to above) – possibility that TA will be restructured to be more targeted to this WG
 - Broader CoC questions – smaller “steering committee” to address questions as needed?
 - Which CoCs have HUD S1, S2, or regional TA?
 - Which CoCs use the CoC Analysis tool or Stella P?
