Meeting Notes from the January 15, 2013 meeting

AGENDA ITEM 1 - INTRODUCTIONS

The meeting began with self-introductions of those in attendance. (See attached list)

AGENDA ITEM 2 – REVIEW OF PREVIOUS MEETING (10/16/12) NOTES

The committee reviewed and approved the meeting notes as written.

AGENDA ITEM 3 - FIRST AND SECOND QUARTER FY 2013 CONFORMITY REPORTS

COG/TPB staff distributed and reviewed the final conformity for first quarter FY013 and the draft second quarter FY 2013 conformity statements.

AGENDA ITEM 4 – TDM EVALUATION FRAMEWORK

Nicholas Ramfos, COG/TPB staff, presented to the committee new guidelines for the TERM evaluation methodology in regards to the employer outreach component. The factors measure impacts from information collected on the employer outreach database as well as employer surveys. There are changes are in how the regional model works and what inputs are to be used. COG/TPB staff will be visiting certain jurisdictions to discuss how repackaging the data can assist getting information out to a larger audience. Capital Bikeshare will be a part of the evaluation framework. The Bikeshare program will be seen as a support initiative but will be under review for future TERM evaluation periods.

AGENDA ITEM 5 - THIRD PARTY VANPOOL

Charlie Richardson of V-Ride updated the group on what products are available to employers who are interested in vanpools. V-Ride was formerly known as VPSI and has over 6,000 vanpools across the country. Among the products offered are: mapping analysis; surveys; and, ride matching data. The vans offered range from 7 person to 15 person vehicles. Luxury vans are also available, customized to riders' specifications. V-Ride is also working with Avego to further the "dynamic ridematching" effort nationwide. Michelle Landrum of Enterprise related what her company does for vanpooling, detailing Rideshare Enterprise (started in 1994). With changes to the commuter benefit advantages lie for those commuters with shorter distances from home to their worksites.
