> The Transportation Planning Section has maintained a four-step travel model, TransForM, containing enhanced zone and network detail that is not available in the MWCOG model, to support planning activities. The most recent ongoing updates to this model include a combination of disaggregate demand modeling and dynamic traffic assignment to extend the types of alternatives that can be evaluated. Another update is in the area of supporting the development review activities by standardizing preliminary evaluations.
