DECISIONS AND ACTIONS:

- Short Term
 - Staff will work with new members and FARM's Chair and Vice Chair to schedule a New Member Orientation in March.
 - The orientation was held on March 21st.
 - Here is a link to the agenda, presentation, and updated member roster.
 - The optional tour of the Montgomery County Agricultural Reserve has been rescheduled and set for early September. A Save the Date has been sent to FARM Members.
 - Staff has shared the significantly updated draft of the Healthy Food Access Policy Compendium with the FARM Committee.
 - Review/comment is requested prior to the end of May.
 - FARM's Executive Committee will send a letter to the congressional delegation for the COG region in support of extending USDA's waiver authority on school meals.
 - The letter was sent on February 28th.
 - Staff from Congressman Steny Hoyer's Office reached out to discuss the letter. COG Staff and FARM Member Michael J Wilson spoke with them on March 3rd to affirm the FARM Committee's request.
 - Staff sent a survey to FARM members to share more information about proposed FARM
 Work Groups open to members and alternates and to assess capacity and interest.
 - There is sufficient interest to form two Work Groups, one on Outreach and another on Catalytic Opportunities. Staff will be in touch with interested members to set up first meetings.

NEW MEMBER WELCOME, FARM ANNOUNCEMENTS, AND MEETING SUMMARY APPROVAL

District of Columbia Councilmember Mary Cheh, FARM's Chair, called the meeting to order at 11:02 am.

Chair Cheh welcomed several new FARM committee members. Now that FARM is a permanent committee, all COG member jurisdictions can appoint members.

Action Item: A new member orientation will be scheduled in March.

The Chair provided a recap of FARM's work in 2021.

Councilmember Cheh announced the release of a working draft of the *Healthy Food Access Policy Compendium for Metropolitan Washington* and the regional food security legislative tracker.

- FARM Members received the legislative tracker prior to the meeting and were asked to alert staff to bills of regional significance that align with COG's 2022 Policy Priorities.
- Bills not included can also be added to the tracker.
- Healthy Food Access Policy Compendium for Metropolitan Washington will be published at the conclusion of the MD and VA legislative sessions to allow for inclusion of additional legislative and policy information.

FARM members approved the December meeting summary.

ADDRESSING FOOD INSECURITY AND RESILIENCE IN 2022 IN METROPOLITAN WASHINGTON: LOCAL HIGHLIGHT

Councilmember Todd Turner, Chair of the Prince George's County Food Security Task Force provided a presentation on the recently released Prince George's County Food Security Task Force Report and Recommendations and discussed next steps.

- He reviewed the Task Force's process, guiding principles, and ten recommendations.
- He emphasized the need for local action and state and regional collaboration to achieve Task Force goals.

- Councilmember Turner answered several questions from FARM members.

ADDRESSING FOOD INSECURITY AND RESILIENCE IN 2022: FEDERAL PRIORITIES AND OTHER KEY STATE AND LOCAL DEVELOPMENTS

Luis Guardia, President of the Food Research and Action Center (FRAC) provided an overview of major challenges and priorities that FRAC is working on now.

- He addressed the importance of programs like the Child Tax Credit and Supplemental Nutrition Assistance Program (SNAP) – and increased funding for SNAP – in avoiding a "hunger cliff."
- FRAC and 2,200 organizations have asked Congress to extend USDA's waiver authority to enable the agency to extend free school meals for the 2022 to 2023 school year.

- They are also tracking several other bills.
- He also invited participants to the upcoming, virtual <u>National Anti-Hunger Policy Conference</u> co-hosted by FRAC and Feeding America.

Action Item: FARM will send a letter to the congressional delegation for the COG region in support of extending USDA's waiver authority on school meals.

Radha Muthiah, CEO of Capital Area Food Bank (CAFB), discussed CAFB's plans for 2022.

- Ms. Muthiah shared how CAFB has been responding to increased need as a result of the Omicron variant, and how the organization is planning for distribution for the remainder of this calendar year.
- CAFB will be releasing three reports this spring: the 2022 Hunger Report and reports on childhood food insecurity and senior food insecurity.

UPDATE: REGIONAL FOOD AND WATER RESILIENCE CATASTROPHIC PREPAREDNESS GRANT

Mark Scott, Critical Infrastructure Specialist with the District of Columbia Homeland Security and Emergency Management Agency (DC HSEMA) provided an update on the Regional Catastrophic Preparedness Grant.

- DC HSEMA is undertaking this work with partners in metropolitan Washington on food and water resilience planning.
- Mr Scott shared key questions, some findings and data analysis that was used ahead of a recent storm event, and a schedule of key project milestones.

- Mr. Scott is expected to brief FARM again as the project proceeds.

FOOD FLOWS: POTENTIAL POST-PANDEMIC PATTERNS RELEVANT TO METROPOLITAN WASHINGTON

Philip J Palin, a subject matter expert on supply chain resilience, and consultant to the food and water resilience planning project, provided an overview of the grocery supply chain.

- Mr. Palin shared how this industry, a critical source of nutrition for the region, has changed during the pandemic.
- He highlighted trends to consider for the future including sales, market leaders in the region, the projected growth of e-commerce, the importance of building relationships outside of the region, and more.

FARM members shared several questions with Mr. Scott and Mr. Palin, many related to stakeholder engagement and policy recommendations.

- Owing to a lack of time, these will be discussed further in the future.
- Councilmember Jon Stehle (Vice Chair) thanked everyone for their continued engagement in the committee.
