### AGENDA ITEM 4 – NEW EMPLOYER OUTREACH GOALS AND CONTRACTS FOR FY2008

The committee received information regarding the new outreach goals for the sales jurisdictions. A chart detailing the new goals and current stable of clients was distributed to the group for their review. The committee was also updated on the upcoming changes to the contracts and scope of work details for the upcoming fiscal year. The new templates will be distributed to the committee members and submissions are due by June 30, 2007.

### AGENDA ITEM 5 - ACT! DATABASE DISCUSSION

Staff updated the committee on the new ACT! database software upgrade and training timelines. The new application will have expanded tab selections to reflect the various fields needed for data collection. Further, the new application will streamline information regarding commuting benefits. There will be a training session in June, and the application is expected to go live in July 2007.

### AGENDA ITEM 6 – REGIONAL TELEWORK UPDATE

Mr. Nicholas Ramfos of COG updated the Committee on recent regional Telework outreach efforts. There will be Telework training sessions in May to be held here at COG. The committee asked if there is a curriculum available and Mr. Ramfos replied that the contractor is currently developing the materials.

# Agenda Item 7 – EMPLOYER SALES PORTFOLIO UPDATE

The committee was presented with the new Employer Sales portfolio demo and asked to select from several designs. Ms. Eileen O'Donnell of Bus Design and Mr. Douglas Franklin of COG gave the presentation. The portfolio would emphasize the network aspect of the Commuter Connections program. The three concepts were: (a) Network Concept – colorized by jurisdiction, it would have a folder with collateral and a business card for content; (b) Window of Opportunity – the folder design would have four squares or window panes with custom photos in each which
