DECISIONS AND ACTIONS:

- Short Term
 - FARM members approved the October meeting summary with a quorum.
 - Vice Chair Stehle presented draft food and agriculture legislative priorities for consideration by the COG Board in its annual legislative priority adoption process. He directed staff to make changes recommended by FARM.

WELCOME, CALL TO ORDER AND MEETING SUMMARY APPROVAL

- District of Columbia Councilmember Mary Cheh, FARM Chair, called the meeting to order at 11:02 am.
- FARM members approved the October draft meeting summary with a quorum.
- Chair Cheh shared that on Monday, December 5th, the Chair and Vice Chairs sent a letter to the region's Congressional delegation.
 - Shared the COG Board's Resolution calling on Congress to make the Child Tax Credit permanent and to provide a pathway for universal, free school meals.
 - It also expressed support for the Healthy Meals, Healthy Kids Act which is the Childhood Nutrition Reauthorization Bill and asked that these priorities be included in any end of year Omnibus Appropriations bill.
 - This was an outstanding action item for FARM.

FEDERAL UPDATE ON FOOD SECURITY AND HEALTHY FOOD ACCESS

- Ellen Teller, Director of Government Affairs at the Food Research and Action Center (FRAC) talked about changes in Congress current and upcoming and how an end of year spending bill could shape up.
- Teller discussed issues of importance to COG and to FARM, including the Child Tax Credit and Childhood Nutrition Reauthorization (CNR) and what could make it in to the Appropriations Bill
- Virginia Representative Bobby Scott passed CNR out of the House Education and Labor

Committee.

- The multi-year bill likely costs around \$100 billion dollars
- Needs to be deficit neutral when it goes to Senate
- Key pieces of CNR are being prioritized such as a summer EBT program, WIC modernization, getting an additional meal for the CACFP program, changes to summer meal programs in rural areas, etc.
 - There seems to be bipartisan support for these.
- Healthy Meals for All does not have bipartisan support and will not be included.
 - Advocates and some members of Congress are pushing for expanding the Community Eligibility Provision instead so that more schools with a certain percentage of low-income children can serve free meals to all students.
 - o Teller explained three different ways this could be expanded.
- CNR will not be taken up next year and compete with the Farm Bill.
 - o It's important to get key provisions into the end of year Appropriations Bill.
- FARM Members spent some time discussing what it could mean to have CEP statewide.
 - Michael J Wilson talked about what some states are doing to support Healthy Meals for All and what is happening in Maryland to better measure poverty and increase access to free meals.
- Cassie Edner, Public Benefits Attorney and Virginia Hunger Solutions, Director at Virginia Poverty Law Center discussed how federal changes to school meals could help in the Commonwealth.
 - A Summer EBT Program would also be really helpful. Particularly in rural communities, it can be very difficult to get to free summer meal sites.
 - A priority for the legislative session is to increase the SNAP minimum benefit, particularly for seniors.
 - They will be especially impacted when SNAP Emergency Allotments expire.
- LaMonika Jones, Interim Director at DC Hunger Solutions, shared a number of initiatives they are working on, including to support DC's state agencies. A few of these include:
 - o WIC modernization
 - Introducing a Healthy Meals for All Bill
 - Senior Hunger
- Ms. Jones also shared how some of DC's local laws and programs already provide for meal benefits to children that are being sought federally.
- Julia Gross at Maryland Hunger Solutions provided a brief preview of priorities for the Maryland legislative session including: Healthy Meals for All, full funding for Maryland Meals for Achievement, protection and reimbursement for funds stolen from SNAP participants through fraudulent activities, and expanding Categorical Eligibility to enroll qualifying residents for programs they're eligible for.

FARM BILL 101

Emma Scott, Clinical Instructor in the Food Law and Policy Clinic at Harvard Law School, provided a high-level overview of the titles in the U.S. FARM Bill which is set to expire next September.
