The Virginia Department of Transportation (VDOT) requests an amendment to the FY 2013-2018 Transportation Improvement Program (TIP) to add funding for the Route 606/Loudoun County Parkway/Old Ox Road project. VDOT will reconstruct and widen Route 606 to a four lane divided roadway with a continuous shared-use path along its north side between Route 621 (Evergreen Mills Road) and Route 267 (Dulles Greenway). This project will relieve congestion and increase capacity of the Route 606 corridor in accordance with the Loudoun County Transportation Plan. The project corridor consists of 5.283 miles.

The amendment adds approximately \$104 million to the TIP, including \$900,000 for preliminary engineering, \$21 million for right-of-way and \$81.7 million for construction. Loudoun County is contributing \$41.2 million for the project and the Metropolitan Washington Airport Authority (MWAA) is providing \$24.45 million. For administrative reasons, the proposed funds are listed under two VDOT identification numbers (UPC 97529 and UPC 105064). Separate TIP funding tables are included for each UPC number.

The Route 606/Loudoun County Parkway/Old Ox Road Project is included in the 2012 and 2013 CLRP updates. The regional air quality conformity analysis for the 2012 CLRP has been approved by the Federal Highway Administration (FHWA) and FTA and the conformity analysis for the 2013 CLRP has been adopted by the TPB. As such, this proposed amendment will not require revisions to the regional air quality conformity analysis.

The proposed funds are based on the recent allocations of funds by the Commonwealth Transportation Board as part of VDOT's FY 2014-2019 Six Year Improvement Program. While the proposed funds are new to the TIP, they are part of the total federal and state funding estimates included in VDOT's financial plan for the 2010 CLRP update.

VDOT requests that this TIP Amendment be considered and acted upon by the Transportation Planning Board's Steering Committee at its meeting on November 1, 2013. VDOT's representative will attend the meeting and be available to answer any questions about the amendments.

WHEREAS, the National Capital Region Transportation Planning Board (TPB), which is the metropolitan planning organization (MPO) for the Washington Region, has the responsibility under the provisions of the Moving Ahead for Progress in the 21st Century (MAP-21) Act of 2012 for developing and carrying out a continuing, cooperative and comprehensive transportation planning process for the Washington Metropolitan Area; and

WHEREAS, the Joint Planning Regulations issued in February 2007 by the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) require a Unified Planning Work Program for Transportation Planning (UPWP); and

WHEREAS, the UPWP is required as a basis and condition for all funding assistance for transportation planning to state, local, and regional agencies by the FHWA and FTA; and

WHEREAS, the FY 2014 UPWP for the Washington Metropolitan Area was approved by the TPB on March 20, 2013; and

WHEREAS, cost-saving measures have resulted in early completion of the 2013 Central Area Cordon Count Technical Report for work activity <u>5.A. Cordon Counts</u>; and

WHEREAS, it is now possible under this work activity with no change in the budget to collect data in the Spring for the Regional HOV Monitoring Project, with the report to be produced during the fall of FY 2015;

NOW, THEREFORE, BE IT RESOLVED THAT the STEERING COMMITTEE OF THE NATIONAL CAPITAL REGION TRANSPORTATION PLANNING BOARD amends the FY 2014 UPWP to revise the project description for work activity <u>5.A. Cordon Counts</u> to perform data collection in the Spring for the Regional HOV Monitoring Project, as shown in the attached materials.

5. TRAVEL MONITORING

A. CORDON COUNTS

Monitoring of the volume of period weekday travel entering the Central Employment Area of the region during the AM Peak Period and exiting the Central Employment Area during the PM Peak Period is performed on a 3 to 4-year cycle. In **fall** FY 2014 staff will process, tabulate and analyze the auto and transit count data collected in the spring 2013 Central Employment Area Cordon Count and prepare a technical report summarizing the key findings and changes from previous Central Employment Area Cordon Counts. Staff will also prepare a technical report appendix containing the detailed auto and transit count data for each 2013 Central Employment Area Cordon Count site.

In spring FY 2014 staff will perform data collection for the Regional HOV Monitoring Project, with the report to be produced during the fall of FY 2015. Staff will collect all traffic data and will coordinate transit data collection among various transit providers operating on several HOV facilities in the region. It is anticipated that the set of regional operating HOV facilities will be the following:

- I-95 / I-395 from Triangle, Prince William County to the 14th Street Bridge in the District of Columbia
- I-66 from Gainesville, Prince William County to the Theodore Roosevelt Bridge in the District of Columbia
- I-270 from Clarksburg to the Capital Beltway in Montgomery County, Maryland
- VA 267 from the Loudoun / Fairfax County line to I-66 in Fairfax County, Virginia
- US 50 Between US 301 and the Capital Beltway
- I-495 Express Lanes in Virginia (via transfer of information from VDOT and/or the roadway operator; field data collection will not occur on this facility)

Data collection will take place during the morning peak period (5am to 10am) and will include vehicle volumes, vehicle classification and auto occupancy, and transit passenger volumes. Travel time runs will also be conducted in these corridors for those facilities where travel time data cannot be obtained from other sources, such as INRIX. Data will be edited, checked for reasonableness, and keyed for processing. The end product for this task will be data files ready to process to produce a technical report in FY 2015.
