2. POLICIES AND PROGRAMS FOR EXISTING BUILDING ENERGY EFFICIENCY
Rodney Sobin, Senior Program Director, National Association of State Energy

Buildings account for almost 40% of U.S. energy use. In the COG region and elsewhere, buildings are the single largest driver of greenhouse gas emissions from both electricity consumption and onsite fuel use. Mr. Sobin will describe how some state and local governments are starting to address the challenge of increasing energy efficiency in existing buildings. While new buildings are required to meet new building energy codes or may seek to meet green building standards, existing buildings, especially older ones, are more challenging to address due to costs, long capital life, and split incentives (e.g., landlord-tenant split incentives). Some localities, such as Boulder (CO), New York City, and Salt Lake City are trying innovative approaches that go beyond benchmarking and disclosure. And this year Washington, DC enacted the Clean Energy DC Omnibus Act which entails aggressive goals and will create challenging existing building energy performance requirements.

Some new initiatives to address equity are in development for the region, including a racial equity training for local government leadership. The recently published report "Uneven Opportunities" is helping inform these efforts. COG is preparing to apply for a grant to fund a related climate resilience, health, and equity project. COG is seeking ACPAC's assistance as COG develops the concepts into concrete plans over the next year.

- ACPAC members are cordially invited to attend the April 4 CEEPC meeting
 which will be held at the Washington Auto show at the Washington
 Convention Center. Attendees will be able to tour the electric vehicle track at
 the Auto Show as part of the meeting's activities. More details to come.
- The MWAQC Executive Committee is planning to review and submit a comment letter in early April on the proposed cost-benefit calculations in the Mercury and Air Toxics rule, which would no longer account for particulate matter cobenefits. MWAQC's concern that this new procedure could set a precedent and be used in the future for criteria pollutants NAAQS evaluations.
- COG is working with Virginia staff to secure funding for the Army Corps of Engineers study which will examine current and future hurricane inundation risks and solutions along the northern Virginia side of the Potomac river.
