- Purchased two next-generation hybrid-electric buses
- 33 new hybrid-electric buses began service in St. Paul and communities in the east metro
- Achieved highest maintenance reliability in service history: 7,456 miles between road calls
- Opened 180-space park & ride lot in Little Canada with express service to Minneapolis and St. Paul



### Regional Priorities for Bus



### 2011 Regional Priorities for Bus

In developing an updated list of priority projects for bus across the region, the TPB Regional Bus Subcommittee focused on eight major themes that meet regional bus customer and agency needs:



- 1. Serving Customers
- 2. Connecting the Region
- 3. Bottlenecks and Hot Spots Bus Access to Regional Hubs / Activity Centers
- 4. The DC Core Downtown DC Bus Center & Bus Stops
- 5. Regional Transit and Intermodal Transfer Centers
- 6. Providing the Fleet Bus Facilities
- 7. Service Needs and Changes
- 8. Federal Relocation & BRAC

#### Sample Outline for State of Public Transportation Report

**Introduction: Transit In The National Capital Region** (pictures)

**Regional transit highlights** (pictures, charts, maps, text)

- Statistics by mode (local bus, express bus, streetcar, BRT, heavy rail, etc.), not by operator
  - S Ridership trends, Mode of access, etc.
- Notable 2015 transit accomplishments
  - § Metro's SGR progress (how far along)
  - S DC streetcar opening (we hope!)... region's first streetcar since 60s
  - § Metroway opening/expansion into Crystal City... region's first BRT line
  - Silver Line Phase 2 U/C... expansion to region's international airport
  - § Purple Line U/C (???)... region's first LRT line, § Etc.

#### Regional transit priority themes (maybe 4-6)\* (text, pictures, maps)

- Transit preferential treatments
  - S Dedicated lanes (stats on potential benefits, travel time savings, etc.)
  - § TSP, queue jump lanes, etc. (w/ stats)
  - Soff board fare payment (stats on dwell times, etc.)
- Core capacity needs
  - § Metrorail (healthy core, crowding relief, etc.)
  - § MARC/VRE? (Union Station/Long Bridge?)
- Transit support facilities
  - S Ridership demand misaligned with facility availability (core, E/W divide)
  - Storage/maintenance/other support needs

#### Sketch-level financial analysis for needs by mode (ex: bus/BRT \$500M in garages, heavy rail: ~\$300M, etc.)

Estimates of increased operating costs due to lengthened deadheading, e Etc.

### MAP-21 Rulemaking Schedule - Upcoming

- Highway Conditions
  - Pavement and Bridges Performance Measurement Rule (Published)
  - Asset Management Plan Rule (1/28/15)
- Congestion and System Performance
  - System Performance Measures Rule (4/20/15)
    - includes Congestion Mitigation and Air Quality (CMAQ) Performance
- Transit Performance
  - Asset Management (June 2015)
  - Safety (National Program, Agency Plan, and Management Systems)

FHWA/FTA have indicated their intention for all of the final performance rulemakings to have a common date of effectiveness.

- The apparent goal is for October 1, 2015, with initial reports on performance measures and targets required as early as October 1, 2016.
- Some rules (e.g., transit state of good repair and asset management) appear likely to be delayed beyond mid-2015 and their implementation would be correspondingly delayed.
