FY 2018 – TPB Transit Planning Activities

- 2045 Visualize Long Range Plan
 - Approval scheduled October 2018
- Transit Asset and Transit Safety PBPP
 - Transit Asset
 - TAM Plan due by October 1, 2018
 - Targets due to FTA by October 31, 2018 (annually within 4 months of end of provider's FY as part of NTD Report)
 - Public Transportation Agency Safety Plans rule Expected May 3, 2018

LRPTF Endorsed Initiatives

LRPTF Initiative - Regionwide Bus Rapid Transit (BRT) and Transitways - Survey

The board is interested in how to monitor and encourage the implementation of projects, programs, and policies that support the initiatives.

As part of the March 27 RPTS meeting notice, a survey for the illustrative BRT systems in the BRT initiative was sent out to get a status update on each of the projects

❖ Regionwide Bus Rapid Transit (BRT) and Transitways: BRT, transitway, and streetcar routes that are in jurisdictions' plans but not yet in the TPB's long-range plan would be added at various locations throughout the region. This initiative would also improve pedestrian access to transit stations and increase the amount of jobs and housing around the transit stations.

In future RPTS meetings we would like to collect input on moving towards implementation of these BRT and Transitways initiatives.


