About MATOC

- Established in 2008, MATOC is a joint program of the District of Columbia, Maryland, and Virginia DOTs and the Washington Metropolitan Area Transit Authority (WMATA)
 - Mission: regional situational awareness of transportation conditions and incidents
 - Goals: improve traveler safety and reduce transportation delays
- MATOC activities include:
 - Monitoring and communicating reliable information during major incidents
 - Enabling operating agencies and the traveling public to make effective, coordinated and timely decisions
 - Maintaining a web-based transportation information system
 - Facilitating standard operating procedures among transportation agencies











Organization and Funding

- University of Maryland is the organizational home of MATOC, collocated with the University's CapWIN program in Greenbelt
- FY2011 MATOC Work Plan approved by MATOC Steering Committee – work underway
- Funding: \$1.24 million committed for FY2011, sufficient to maintain MATOC core work program (changes vs. Sept. presentation noted in bold)
 - MD SHA \$400,000 flowing
 - DDOT \$400,000 agreement / contracting in process
 - VDOT/NVTA \$150,000 reflects additional \$50K commitment by VDOT, agreement / contracting in process
 - FTA Earmark \$200,000 agreement / contracting in process
 - COG/TPB \$90,000 flowing












MATOC Operations Floor (Collocated with CapWIN Offices)

Notifications and Coordination

- MATOC Operations Staff is now providing incident notifications to more than 3 dozen traffic, transit, and public safety operations stakeholder agencies / offices
 - DDOT, MDOT, and VDOT operations
 - WMATA and local transit agencies
 - Police, homeland security, and emergency management agencies
- MATOC provided notifications for 58 incidents in October
 - Estimated \$1 million of delay reductions and other benefits regionally, benefit –
 cost ratio > 10:1
 - 70% of incidents on freeways, 30% on non-freeways (including transit)
 - The number of notifications has been increasing over time due to enhanced efforts and expanded hours











MATOC Involvement in Regional Coordination – Example Major Incidents

Wednesday, September 29

- Building fire, 16th St. NW in DC between Harvard St. and Park Rd., street blockage, bus and traffic detours (morning rush)
- Charter bus crash (driver medical emergency), I-270 West Spur north of Democracy Blvd.,
 Montgomery Co., extended road closure and backups (evening rush)

Wednesday, October 13

- Freight train stopped after pedestrian crash
- Disruption of afternoon rush hour MARC Brunswick Line service, and blockage of Randolph Rd

Major Rallies

- Labor rally Saturday, October 2; Rally to Restore Sanity and/or Fear Saturday, October 30
- MATOC staff on duty, monitored situation and made notifications as necessary, including on the key Metro parking facilities becoming full (October 30)

In all cases, MATOC:

- Sent out notifications to transportation agencies as soon as confirmed information was available regarding the incidents; monitored situations as they evolved
- Provided ongoing incident update notifications regarding road closures, detours, transit impacts, or incident close-outs
- Through its notifications, aided agency decision making on transportation management









An overturned bus has closed the I-270 Spur Northbound, north of Democracy Blvd. I-495 Northbound traffic cannot access I-270 Northbound. I-270 Southbound HOV lane is partially blocked by emergency vehicles. Alternate routes are advised, stay away from this area.

MATOC will update this incident as the situation changes.

DISTRICT OF COLUMBIA

- Incident at Martin Luther King Ave and Howard Road has cleared, roadway reopened.
- Chain Bridge is closed due to schedule construction, scheduled to reopen on Monday at 5am.

MARYLAND

 Metro Parking Lots at Greenbelt & New Carrollton are reported at capacity, traffic being turned away, stations remain open.
 SHA assisting with highway signage.

VIRGINIA

 Heavy Congestion, I-66 Eastbound, Exit 62, significant delays to exit onto Nutley Street towards Vienna Metro Station

MATOC will provide hourly updates until 6pm.











MATOC Involvement 9/1/10 – Discovery Communications Incident

1:20PM Incident Detection via police/fire scanner. Media reports of a "situation in Downtown Silver Spring"

- CCTV visual of Georgia Avenue & Fenton Avenue shows police vehicle blocking roadway

1:30PM Confirmed with MD SHA: "Police Activity closing will be Georgia Avenue completely"

- Sending CHART assets to asses situation, planning to assist county with closures

1:45PM MATOC Situational Awareness Alert: "Due to police activity in downtown Silver Spring, Georgia

Avenue is closed in both directions between Colesville Road and Wayne Avenue. Traffic is being detoured away from this area. Please avoid traveling near or through downtown Silver Spring"

2PM-3PM

Road closure perimeter quickly expanding, main entrance of Silver Spring METRO Station closed DDOT TMC requesting more information from MATOC

- Will deploy Traffic Control Officers & Variable Message Signs to assist MD SHA & County

MD SHA advises CHART units in place. Will retime signals on alternates routes for PM Rush HSEMA pages RICCS "Transportation Incident"

DDOT issues Traffic Advisory: Use Eastern Ave to 16th Street or Piney Branch Road as an alternate Metrobus routes detoured away from Silver Spring Metro Station, modify pickup/drop off points

3PM-4PM

Road closures, detours, and signal timing are in place
Outbound traffic flowing steadily around Downtown Silver Spring without incident












9/1/10 – Discovery Communications Incident Timeline from RITIS Software







Transit, Urban Areas, and MATOC

- MATOC continues to engage transit agencies / staffs in activities and notifications
 - Subcommittee participants have included WMATA, PRTC reps; all agencies welcome
- Attention to transit incidents as well as traffic incidents that may impact bus routes
- Notification agency list includes a wide range of transit agencies
 - WMATA (numerous departments/offices), Alexandria DASH, Arlington Co. Transit, Fairfax Connector, Fairfax Cue, Loudoun Co. Transit, Montgomery Co. Ride On, MTA, PRTC, Prince George's The Bus, commuter bus services











Outlook

- Ongoing coverage / notifications for the National Capital Region
- Continue to build relationships between the MATOC operations staff and regional stakeholders
 - Further efforts to strengthen county-level and transit agency involvement
 - Continuing MATOC Facilitator outreach activities / site visits to stakeholder agencies
 - Gathering information / feedback from agencies on how MATOC information aided in agency decision making during the incidents in which MATOC staff participated
- Additional benefit / cost analyses focusing on urban and transit issues (early 2011)
- Development of a public MATOC website (mid-2011)
