



- Share the perspectives of several food providers using a diversity of service models on how they are planning for the potential for cold or inclement weather this winter.

Local and Regional Resources

Preparedness Mantra:

1. HAVE A PLAN

2. MAKE A KIT

(i.e., Make sure you are ready with proper gear for weather)

3. STAY INFORMED

Local Example: Montgomery County Guidance (1/4)

Adapted guidance from Montgomery County EOC to county food assistance providers

- 1. Encourage home delivery when possible.
- 2. Have a backup day and a backup-backup day if there is a snowstorm or similar multi-day storm.
- 3. Plan to store food properly should a pop-up distribution get cancelled to prevent waste.





Montgomery County Guidance (2/4)

- 4. Providers without room to do packing inside should partner with other organizations and consider alternative dispensing sites.
 - Montgomery County has facilitated access to parking garages in a few cases.
- 5. Tents can be used to shelter food boxes but must be secured (e.g., 10 lbs per pole for 10ft x 10ft tents),
 - Tents may not be used when wind gusts exceed 30mph.
- 6. Tent heaters not seen as a workable solution as they have to be 10ft away from tents.
 - Heaters may be used in garages if approved for use by facility.



Montgomery County Guidance (3/4)

- 7. Montgomery County prohibits food packing and dispensing of county-provided food boxes when surfaces are slippery.
 - When snow is present, parking areas and work areas should be shoveled and properly salted ahead of volunteer arrival.
- 8. The county prohibits food packing, dispensing, and delivery of county-provided food boxes when snow affects road conditions.
 - Follow guidance for county school closings/delays.

Montgomery County Guidance (4/4)

- 9. In temps below 40F, outdoor work sites need to adhere to a 5/2-hour work-rest cycle with frequent breaks, and a 1qt/6hour hydration cycle.
 - Warm drinks and hand warmers are encouraged for food security workers to combat the stress of working in the cold.
 - Volunteers not dressed appropriately for the cold must be sent home.
- 10. Food assistance providers should have a backup digital thermometer, since they often fail during cold weather. Both should be stored in warm conditions before use.
 - If the backup fails, notify volunteers.
 - All personnel should use abundance of caution go home if they have any symptoms.



MoCoFOOD Text Alert

In addition to regular alert system, Montgomery County created a public food information text alert system

Notifies the public about food resources, weekly pop up distributions, and any potential disruptions to services.
