1:30 P.M. 10. SAFETY STUDY PHASE 1 ANALYSIS

Jon Schermann, TPB Systems Performance Analysis Manager

Staff will share the results of the regional roadway crash data analysis (emphasizing fatal and serious injury crashes) undertaken as part of the TPB's regional safety study. The study is currently conducting an in-depth analysis of crashes involving pedestrians, crashes at or near intersections, and crashes along principal arterials as well as compiling a set of actions with the potential to improve roadway safety outcomes in the region.
