A. Regional Wastewater Capacity Outlook & Framing the Message- *Tanya Spano* and Mukhtar Ibrahim, COG

Ms. Spano and Mr. Ibrahim will present demographic trends and updated regional wastewater projections for the COG region, and summarize how those projections compare to plant capacity over the next 27-year regional planning horizon. Ms. Spano will also summarize efforts to evaluate flow versus load capacity trends and constraints – on a national & regional level; and note how this work is linked to COG's Region Forward and Economy Forward initiatives.

B. Water Resources Infrastructure Event - Update - Tanya Spano, COG

III. Chesapeake Bay Program Updates & Regional Water Quality Issues (11:00 - 12:00 p.m.)

A. Commenting on the 'New' Chesapeake Bay Agreement - Heidi Bonnaffon

[CBP issued abridged version of new agreement (7/9/13); COG staff drafted initial comments & background for CBPC review (7/17/13); and CBPC comments were sent to the EPA/CBP (7/30/13)]

Ms. Bonnaffon will brief the members on the Chesapeake Bay Program's plans to issue a new voluntary Bay agreement and review initial COG comments. COG's Chesapeake Bay and Water Resources Policy Committee (CBPC) provided preliminary comments in July and plans to provide more detailed comments during a fall comment period.

Feedback: Review comments and provide input on next COG comments.

B. Bay Program Water Quality Monitoring Developments - Karl Berger

The Bay Program is cutting back its non-tidal water quality monitoring network in response to budget pressures. Mr. Berger will review the current status of the network and its tidal monitoring counterpart – and potential implications for the COG region. He will also discuss COG staff plans to partner with the U. S. Geological Survey on a fall 2013 workshop to explore the role of monitoring in Bay TMDL accounting and how local governments can work with the Bay Program to shape the future of monitoring efforts.

Feedback: Provide input on workshop plans.

C. COG & National Dialogues with EPA & States - Karl Berger

Mr. Berger will brief the committee on the CBPC's ongoing dialogue with EPA and the Bay states on water quality regulatory issues, noting the committee's Water Quality Forum on May 17th; note members' participation in a national discussion on affordability and flexibility in water quality permitting; and highlight a proposed initiative by other parties to advance Clean Water Act amendment legislation.
