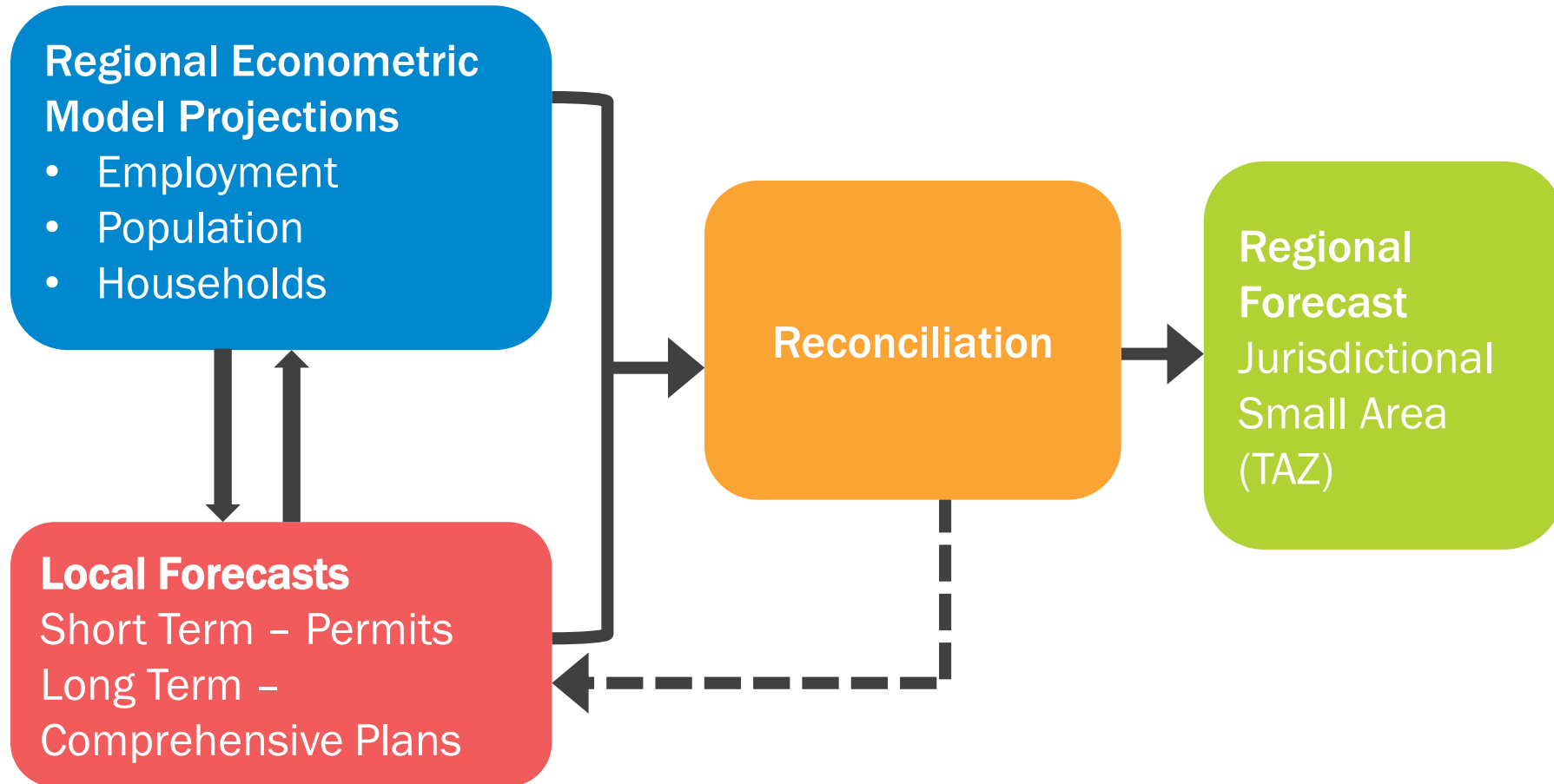

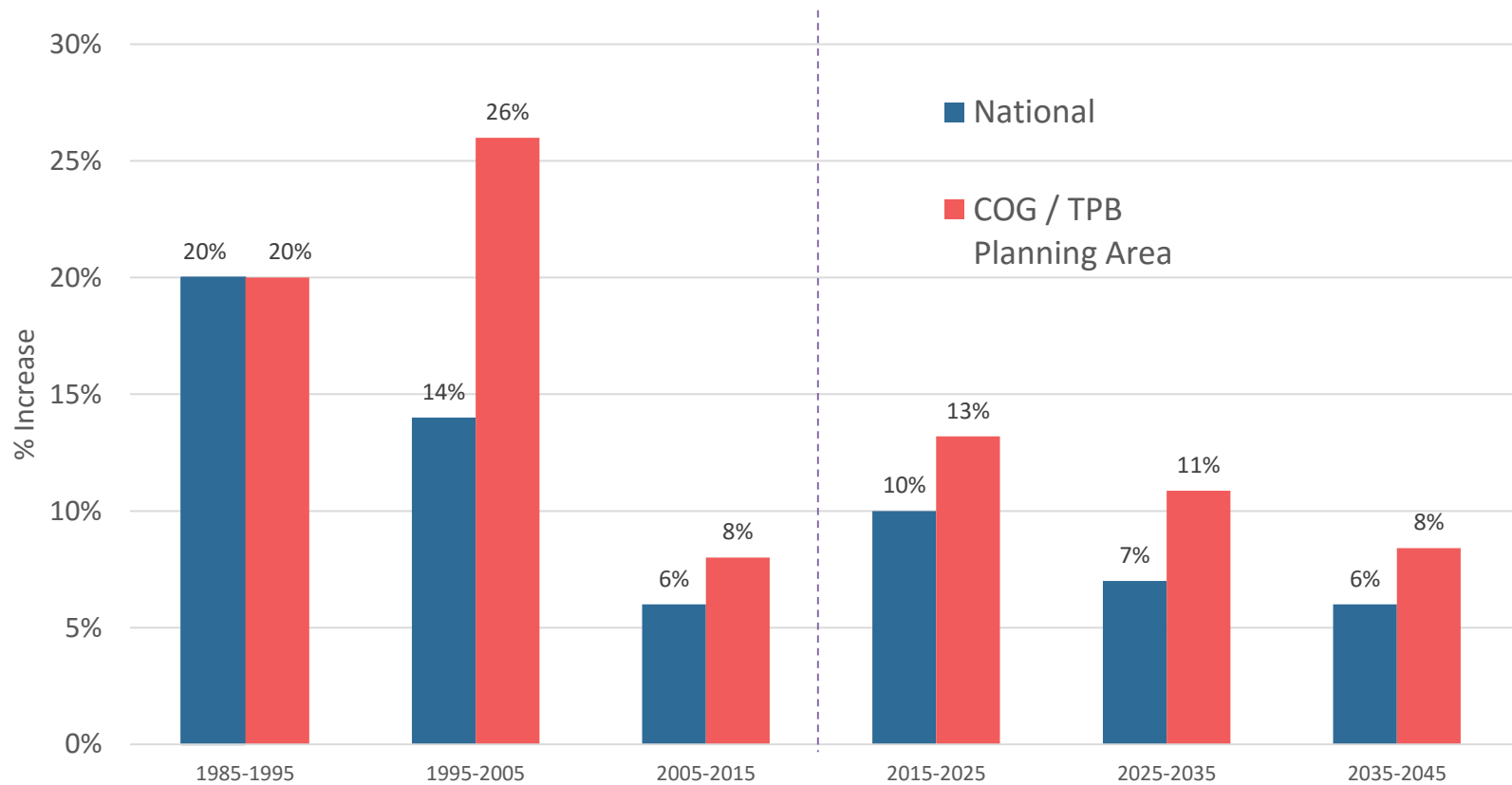

Cooperative Forecasting Process



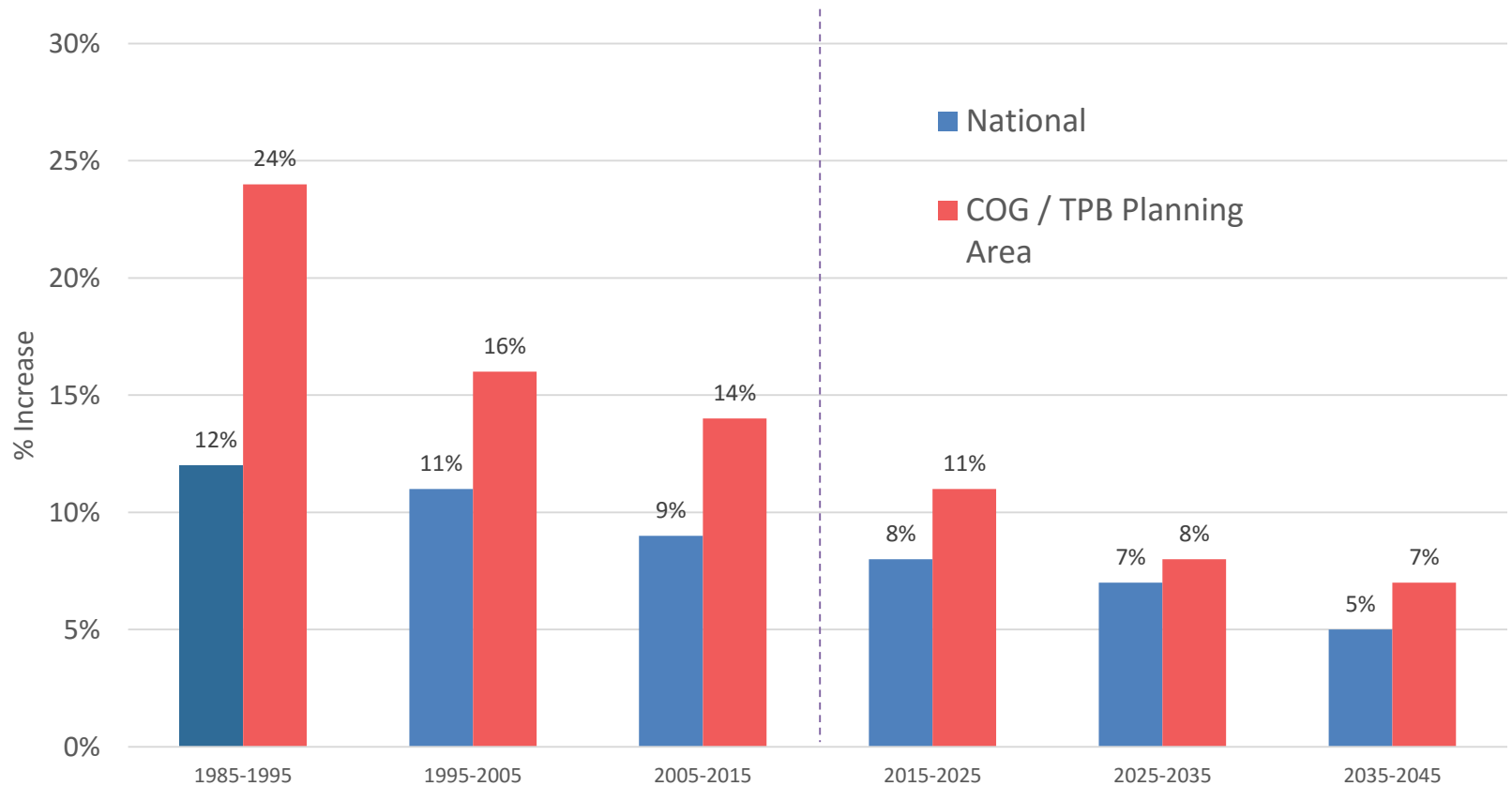
Employment Change by 10-Year Increments National vs. COG / TPB Planning Area

Population Change by 10-Year Increments National vs. COG / TPB Planning Area

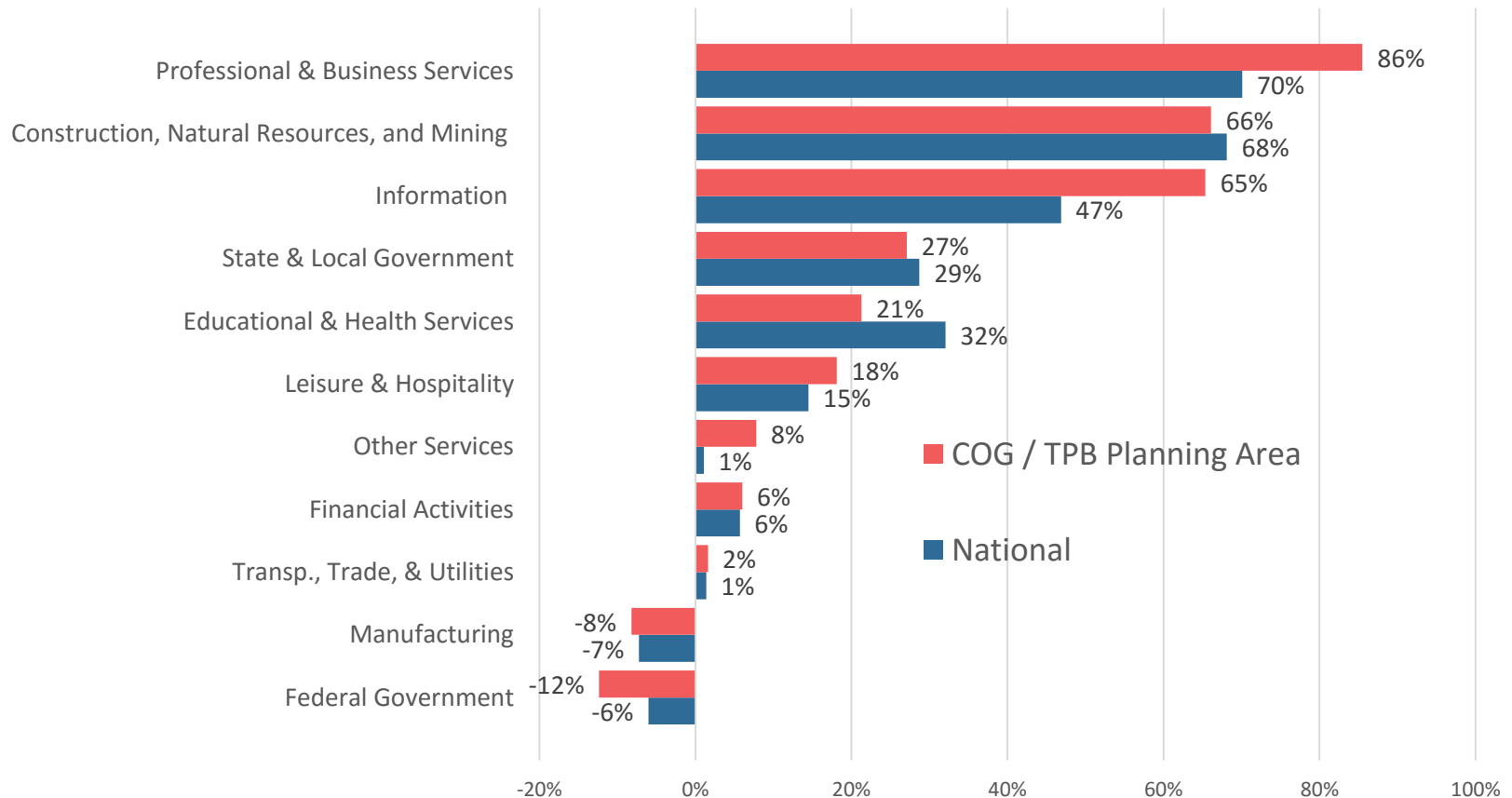

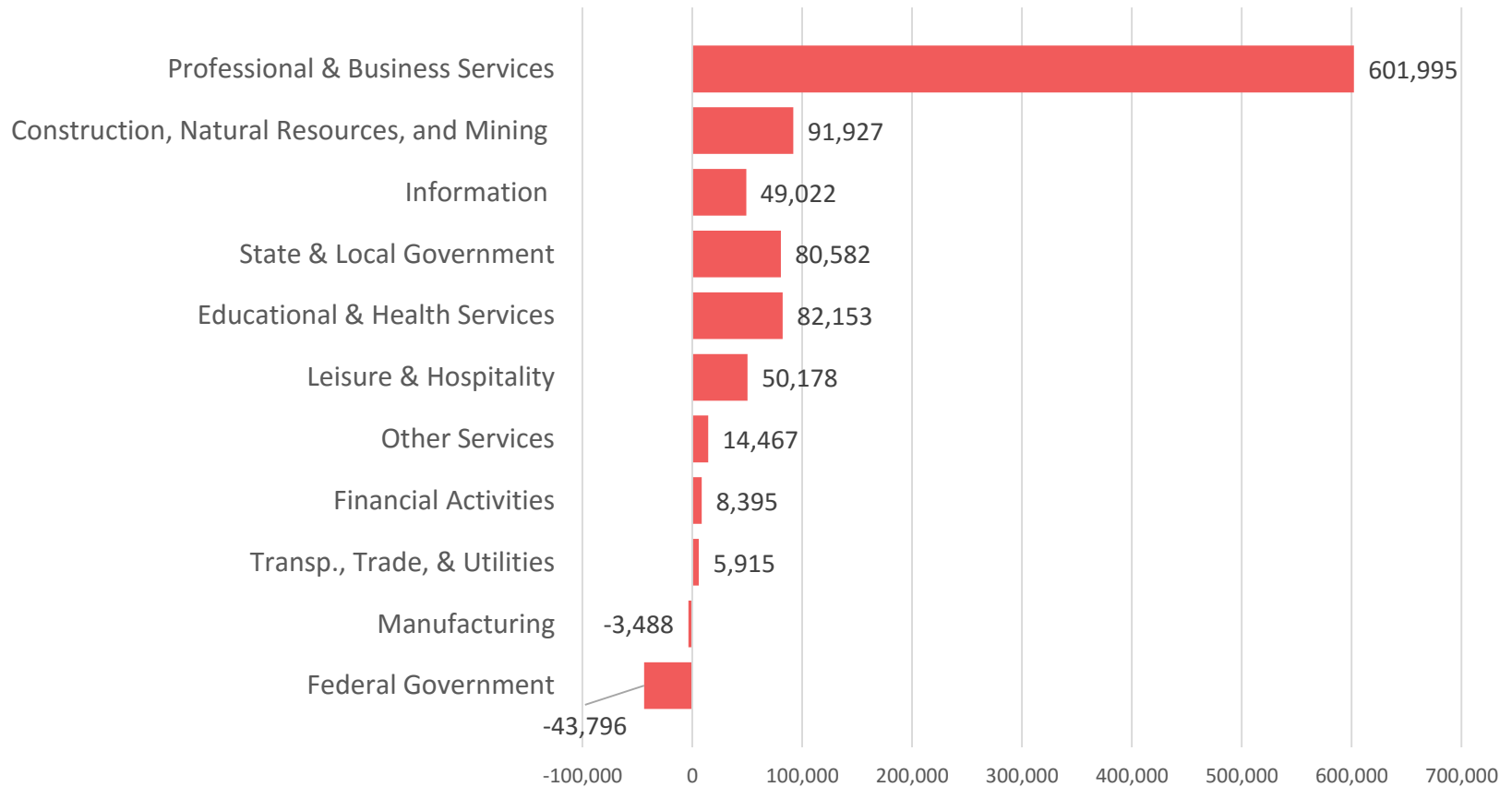
Employment Change by Sector 2015–2045

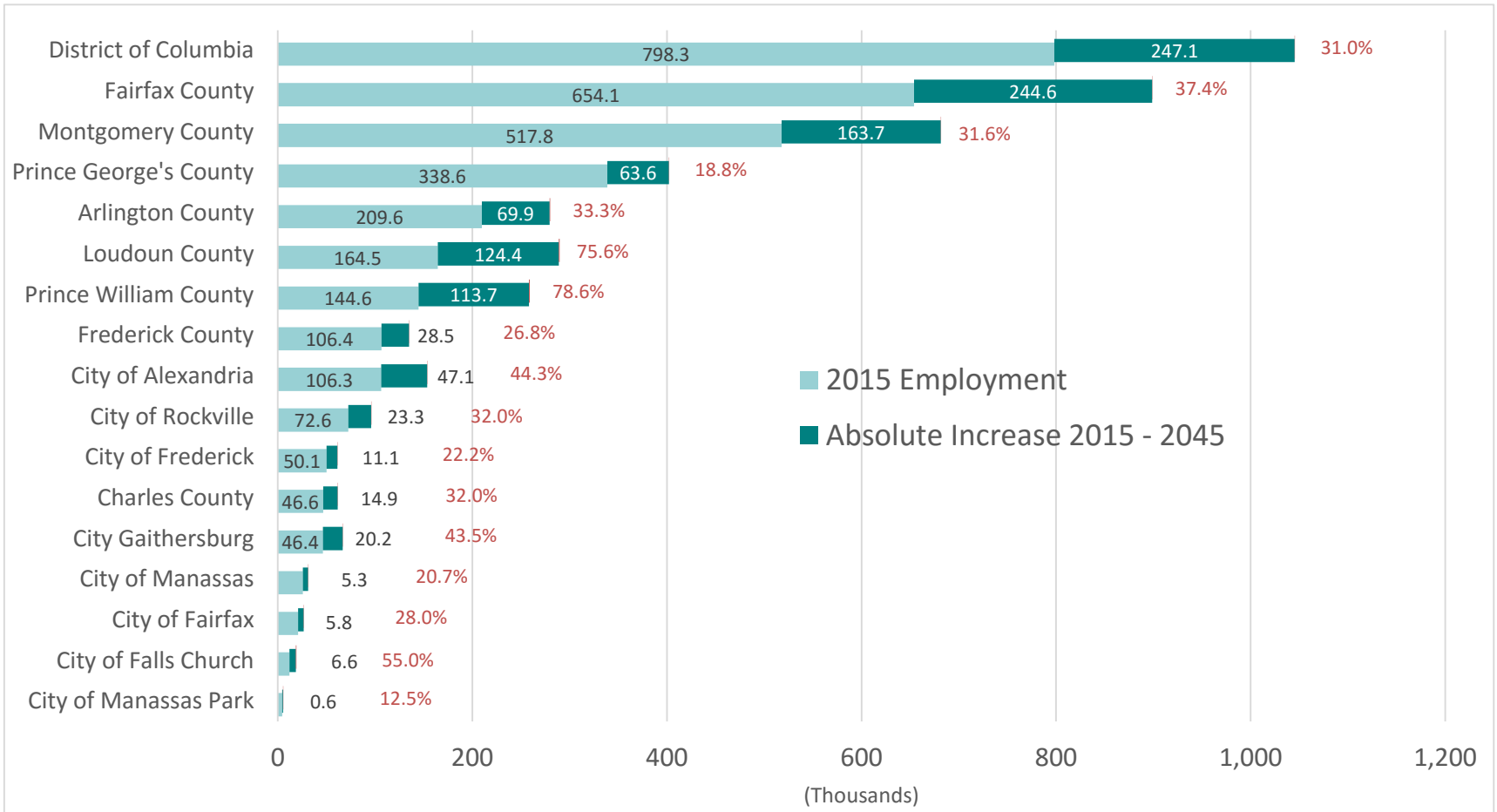

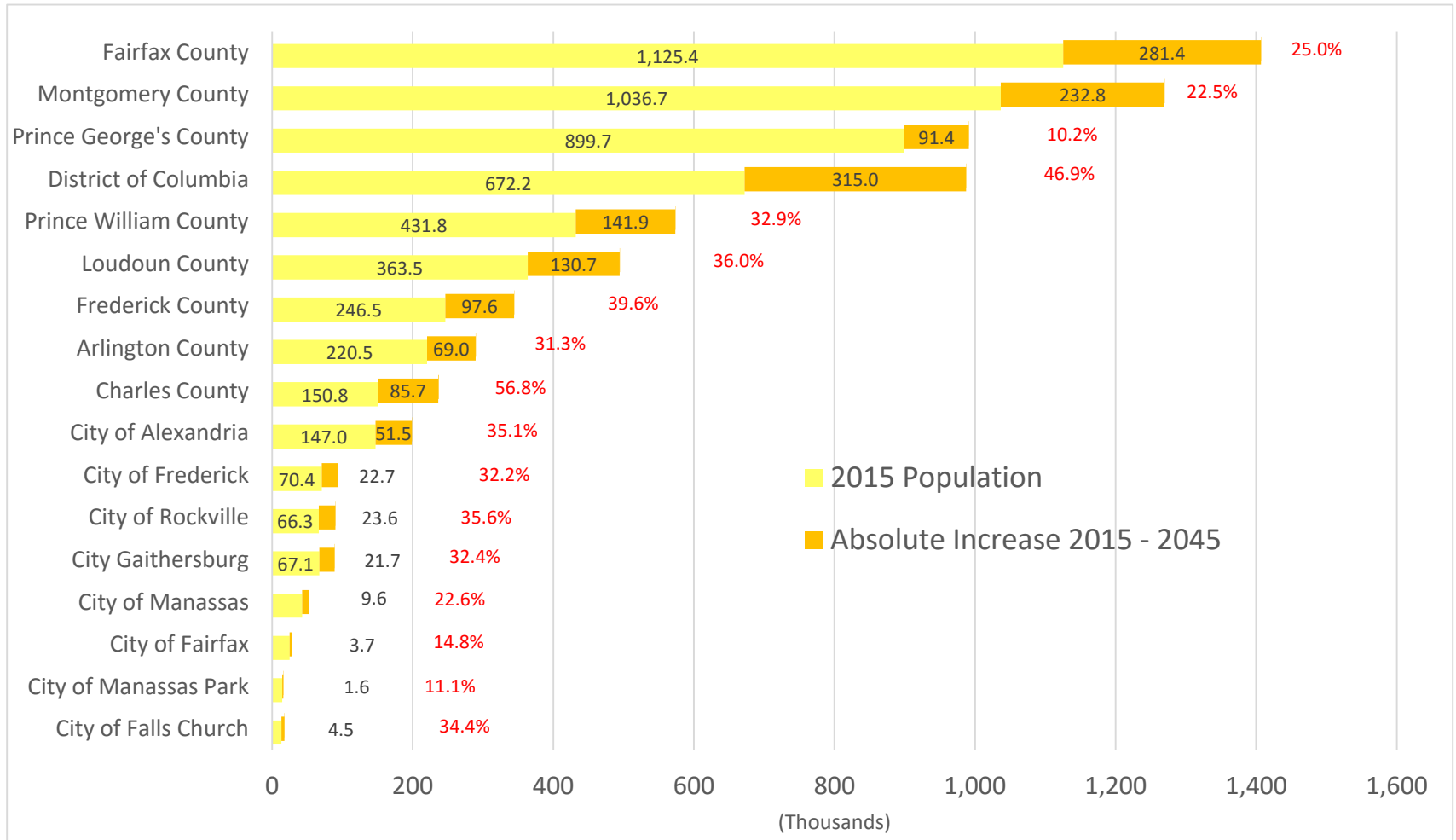

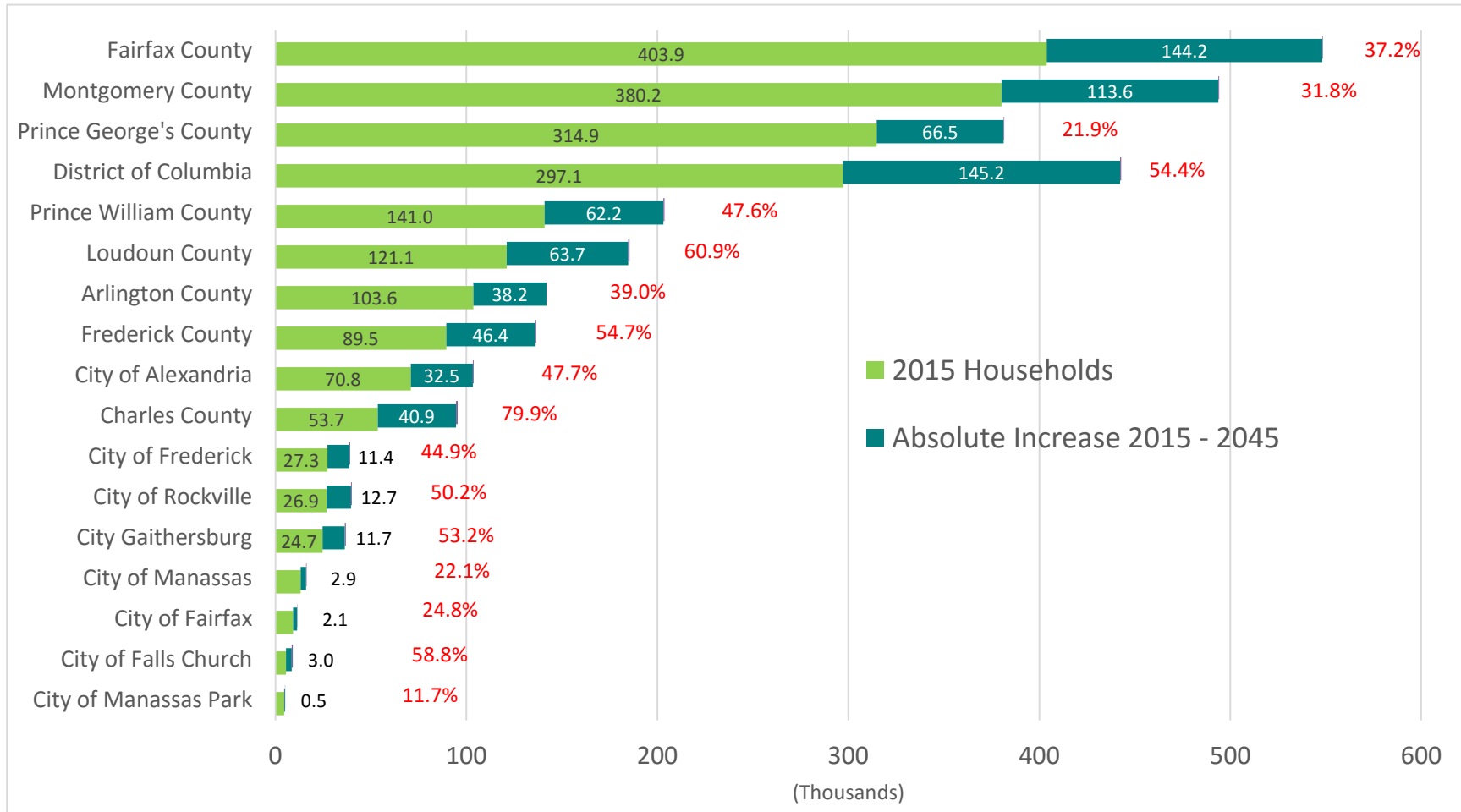
Employment 2015 - 2045



Population 2015 - 2045



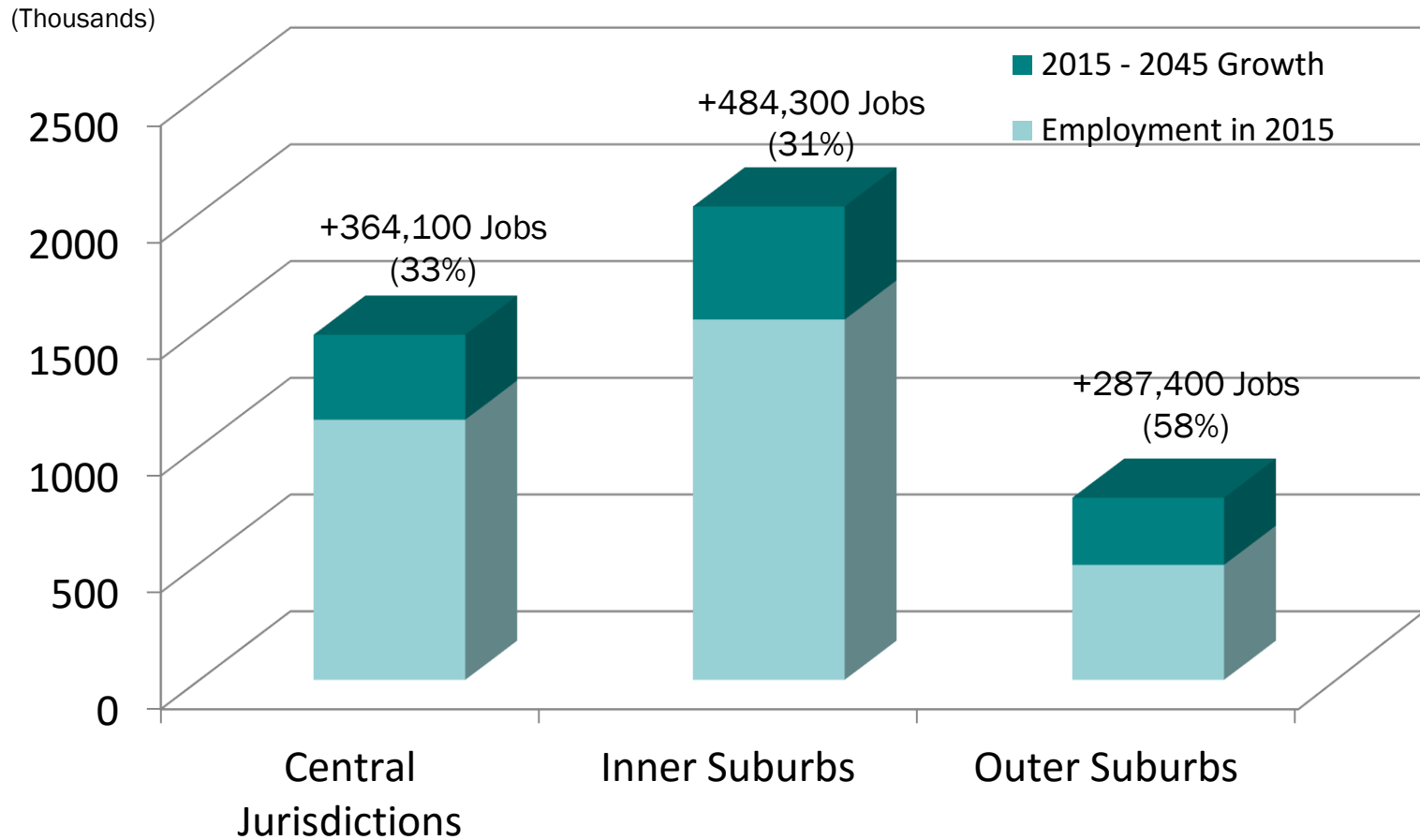
Households 2015 - 2045



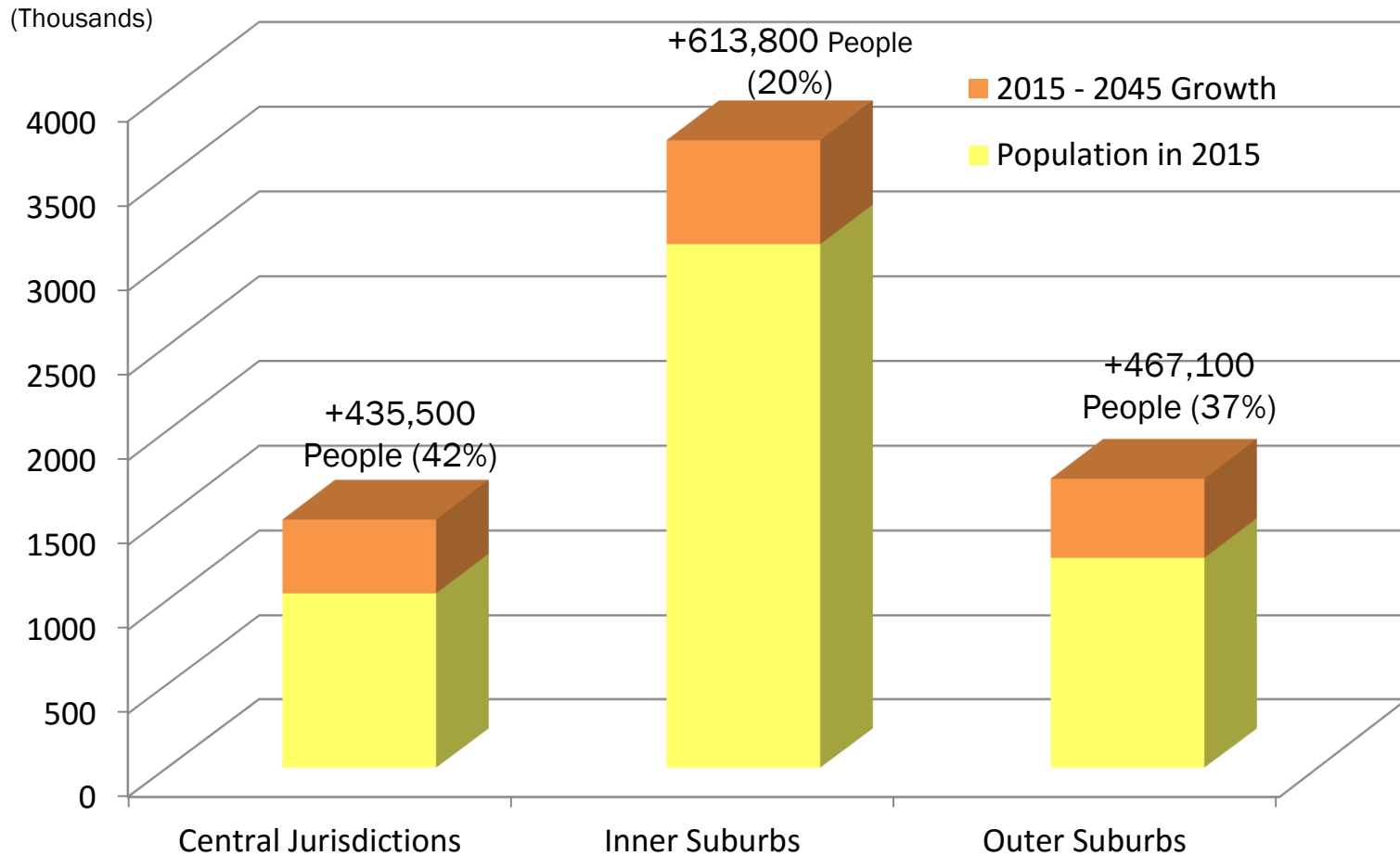

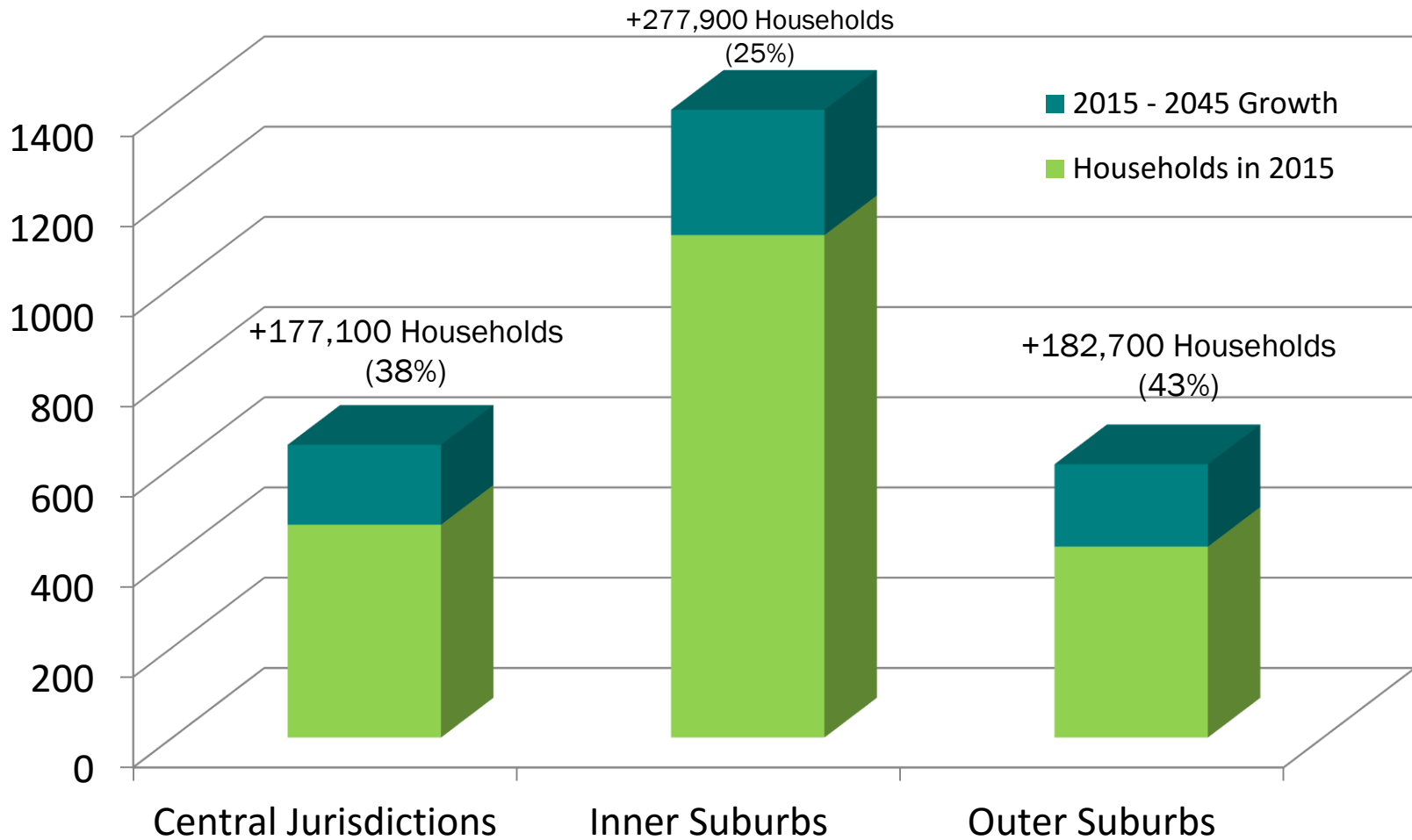
Forecast Employment Growth, 2015 - 2045

- COG Board to approve “Draft Round 9.0” for use in the Air Quality Conformity Analysis of the 2016 Update to the Financially Constrained Long-Range Transportation Plan (CLRP) and the FY 2017-2022 Transportation Improvement Program (TIP) on March 9
- Local jurisdictions submit Round 9.0 forecasts by Transportation Analysis Zone (TAZ) by March 11, 2016
- Final approval and adoption by the COG Board in November 2016
