# Long Range Transportation Plan

GOAL: Improve performance outcomes of the regional Constrained Longrange Transportation Plan


**Development Process:** 

- Inventory of Unfunded Capital Needs Initiated Fall of 2014
- Unfunded Capital Needs Working Group Established Summer 2015
- Phase I: Baseline Report Adopted January 2017
  - 3 Scenarios No-Build, Planned-Build (CLRP), and All-Build (\$100 billion in additional projects) scenarios
  - "All-Build" still showed increased congestion
- Phase II: Develop Plan of Unfunded, Multimodal Priority Projects
  - To include pedestrian and bicycle projects



### **Proposed Bicycle and Pedestrian Element**

- 1. Access to Metrorail
  - Projects identified by WMATA to improve pedestrian and bicycle access to Metrorail
  - Increase effective walksheds, ridership in a cost-effective manner
- 2. National Capital Trail
  - Projects identified in the National Park Service Paved Trails Study as necessary to complete or enhance the National Capital Trail




"The NCT idea is compelling because it is simple, understandable, and refrains from trying to be overly ambitious or inclusive of all trails in the NCR or broader region."



# **National Capital Trail**

- Four connected loops
  - 30 mile northern loop
  - 10 mile central loop
  - 18 mile southern loop
  - 45 mile perimeter loop
- Gives prominence to the core
- Serves all user types and abilities
- Creates opportunities for collaboration, marketing, branding, events
- Implies a priority for implementation

- Basis for potential funding applications, both local and regional
