- Adopt TPB SR16-2025 to amend the TIP to include TIP Action 23-47.2 which adds funding for establishment of and funding for a Bridge Manager Position, as requested by Prince George's County DPW&T.
- Adopt TPB SR17-2025 to amend the TIP to include TIP Action 23-47.3 which adds funding for Fairfax Connector to establish and operate Express Bus Service between Tysons, Virginia and Bethesda, Maryland as a part of the I-495 NEXT Transit Service, as requested by VDOT.
