# **Human Services Policy Committee Proposed Items for Regional Compact:**

- VISION: To create a cross-jurisdictional, client centered approach to ending the
  experience of homelessness by identifying and breaking down barriers to get people
  the resources they need.
- MISSION: By openly sharing and analyzing data across jurisdictions, we can identify gaps in both emergency shelter and housing and effectively advocate for resources to bring an end to homelessness in the Washington metro region.

# 1. DATA SHARING:

 Explore expanding a data sharing agreement held by Prince George's County, Montgomery County, and the District of Columbia, to include all COG jurisdictions to participate. This would allow jurisdictions to share Homeless Management Information System (HMIS) data across the region.

#### 2. REGULAR REPORTING & CASE COORDINATION:

- Develop a regional protocol to ensure consistent reporting. This may include the development of a regional dashboard to share information (i.e., bed utilization, turn aways, client seeking shelter from other jurisdictions).
- To specifically address veteran homelessness, develop point of contacts within each jurisdiction who could connect veterans with the services they need.

#### 3. BY-NAME TRACKING

 Build regional operational protocols to better track individuals being turned away at shelters. This information would show the need and capacity for each jurisdiction.

## **NEXT STEPS IN HSPC JOURNEY TO ADDRESS HOMELESSNESS**

- Prior to HSPC's final 2020 meeting in November, draft up a regional agreement.
- The draft agreement will be shared with HSPC members the first week of November for comment. This <u>draft</u> will be shared with the COG Board on 11/12. The HSPC will meet on 11/13 to provide a further review of the compact and allowing for additional feedback.
  - Recommendation to bring the mission, vision and the items before the board in November as a draft.
- Executive Director Chuck Bean recommends introducing it in a presentation to the COG board, and then bring it back at a subsequent meeting. Key to this is optional engagement.
   It is a coalition of a willing that what makes this possible. Timing for first COG Board presentation is January 2021.
