Mr. Nelson has thirty years experience in community economic development, public interest finance, management consulting, and collaborative environmental policy. He designed and managed the Small Business Opportunity Project for HUD to assist public housing residents to plan and run their own businesses. He directed the urban land trust program for the Trust for Public Land and managed non-profit liaison for the Chevrolet-Geo environmental program. Much of his consulting activity has been in the area of multi-sectored collaboration on behalf of clients in business, government, and the public interest. He has served and continues to serve as a Board member of various national non-profit initiatives and community organizations and as an advisor to several for-profit financial institutions.

Dr. Byrne is chairman of the board of the Foundation for Renewable Energy and Environment (FREE). He also was a founding co-chair and served until June of 2012 of the Delaware Sustainable Energy Utility (SEU) and is the architect of its innovative energy efficiency bond program. His work has been funded by the World Bank, UNEP, the Blue Moon Fund, the National Science Foundation, U.S. Department of Energy, and the U.S. EPA, among others. He has published 17 books and over 150 research articles.
