Previously, Regina was Southeast Director for Corporation for Supportive Housing where she worked with communities to transform systems of care into data and performance driven systems that provide sustainable, permanent housing to those

experiencing homelessness. She has Master's degrees in Counseling and Developmental Psychopathology from Florida State University.
