Regional Mobility and Accessibility Study: Alternative Growth Scenarios

On September 10, 2003, TPB staff briefed the COG Board and MDPC on the Regional Mobility and Accessibility Study (enclosure). Also, since the October meeting, COG/TPB staff and Committee members have been working to refine the zone-level data files for the alternative land use scenarios of the TPB Regional Mobility and Accessibility Study. PDTAC members should come prepared to discuss the new transit facilities they plan to assume under the Transit-Oriented Development (TOD) Scenario as well as the total amount of forecast job and additional household growth that may wish to accommodate in a TOD

alternative. In addition, staff will update the Committee on the scenarios work and next steps in the modeling process.
